**CEO REPORT (Information/Action):** CEO Munson reported that he will be out of the office the rest of the week. It was a great Mother's Day weekend with all the events going on. Currently we are showing approximately \$10,000 profit but not all the expenses are in. There was the incident during the Jackpot Show with the steer collapsing in the ring. It was transported out by sled, loaded into the trailer and taken to UC Davis. CEO Munson tried to follow up with the family this afternoon but has not heard back.

Projects – CEO Munson reported that the Exhibitor Restroom project is on hold and will go through the state process. We have purchased the HVAC unit for the Floral Building and will be doing that as an internal project. Cal-Ore came in lower with the broadband bid so we will be proceeding with them. We will receive free internet for 10 years and we will pay the expense to have it put in with the state resiliency funds that will be received. We did receive a bid from Advantage Paving to repair the area from the sewer replacement in between buildings 1 and 2. This will also expand to the horse area and the exhibitor parking lot to make it wheelchair accessible.

#### **BOARD COMMENTS:**

- Director Allen stated she attended the events on Saturday, and it seemed that everyone was enjoying it. The overall perception was it was good. It would be nice to see more food, music on Sunday and more security at night.
- Director Kutzkey wished she would have reminded Chad McCall about the meeting. He is into safety and security with a lot of equipment and would be a great asset to get involved with the fair.
- Director Hanna said that CEO Munson's raise was well earned.
- Director Mercier said the weekend events were well attended, might need to do some changes to the Jackpot to improve the show and to grow. CEO Munson mentioned that he was approached by sheep and goat people to include them in the jackpot. The dates will be reviewed and maybe it's time to move it away from the other activities going on that weekend.
- President Finley thanked staff for their work over the weekend.

#### **Board Policy**

The 10<sup>th</sup> District Agricultural Association Board of Directors encourage the CEO to reward sustained superior accomplishment by using the State of California – Department of Human Resources form STD. 278 - Superior Accomplishment Gift or Cash Award Recommendation to reward permanent employees.

We are writing on behalf of several Siskiyou County cattle breeders in an effort to implement change in the 2024 SGF Junior Market Steer Show. It is our sincerest wish that the board entertains the idea of changing the current junior "Market Steer" show to a "Market Beef" show that includes market heifers. These are terminal females finished to market-ready standards and fed a grain-based diet (not for breeding purposes or allowed to be shown in breeding classes) and compete alongside their steer contemporaries like every other market division. Currently, the SGF market sheep, swine, goats, turkeys, poultry, and rabbits include both genders and do not discriminate on the basis of sex.

Our U.S. beef supply chain consists of 50% steers and 30% heifers. The remaining 20% of our beef supply are cull cows/bulls that do not grade above cutter/canner. Those grain-fattened steers and heifers in feedlots that meet USDA maturity and quality standards are directly available in every grocery store. Consumers cannot discern any quality differences between the two, nor or they marketed differently.

There are many fairs in California that include both steers and market heifers in a Market Beef show. While many are in southern California like Madera, Chowchilla, Kern, Stanislaus, and Ventura counties; there are north region fairs like Glenn, Humboldt, and Amador counties currently offering this to their junior exhibitors.

Additionally, allowing this change and announcing it during our 2023 fair would afford more options to our local junior exhibitors during the peak buying season immediately following our August fair. This is a crucial time for families as they arrange for their 2024 fair projects and get on local breeders' lists for animals. We are often approached at our August fair for the following year's animals.

Market heifers are a common sight at both feedlots and junior livestock shows. While some education may need to be done locally clarifying that these heifers are terminal and not breeding animals to the juniors raising them and potential buyers, the benefits will outweigh the time it takes to answer and educate. Age requirements and weight ranges would remain the same and the heifers would compete alongside their male counterparts - not altering or changing the structure of the show in any way.

Our fair has a rich and wonderful heritage and an innovative board & staff that pioneer and adapt to meet modern times. We ask that you take the same approach to this outdated rule that should reflect more accurate and updated industry practices for both the exhibitors and our buyers.

We are happy to answer any and all questions that you may have and will have a representative available at the next board meeting should you have questions.
