 - o Saturday Night Event CEO Munson reported that the community still wants a rodeo; it is associated with the annual fair. An RFP will be created, open to CCPRA and non

organizations. A decision of direction will be made after the deadline as to what would better benefit the Siskiyou Golden Fair. No public comment.
