- Transition Plan CEO Munson reported it is looking like one JPA will be formed to include all participating fairs. CFSA, CCA, WFA, etc. would be under the JPA as support of the industry. RCRC will be one of the founding members with 2 counties. The counties do not have control over the JPA they just agree to have their policies and procedures adopted to develop the JPA. The fairs would then form a non-profit for operations and join the JPA. CEO Munson is supposed to receive a plan in the next couple of weeks and it will be reviewed and will be on the County Supervisors agenda November 10th. No public comment.

- Junior Livestock Auction Committee Director Mercier said they are dark until April and they just have a few outstanding buyers left to collect from. No public comment.

LIVESTOCK GRADING EVENT & AUCTION REPORT (Information/Action):

CEO Munson stated again that it went very well. We had the best sale in the state per lot and species. The only issue was the heavy sifting by the judge, but it was a grading not a show. No public comment.

FAIR (Information/Action): The updated California Department of Public Health COVID-19 Industry Guidelines: Amusement Parks and Theme Parks was issued today and after discussion it was unanimous that we begin planning the 2021 annual fair and interim events. No public comment.

- Events
 - Calendar of Events CEO Munson reported Barba Promotions has a few more races in the season, but they are behind on paying the utility fee. Yreka Outlaw Karts is going to do indoor kart racing starting in November. No public comment.
 - Outdoor Holiday Market CEO Munson reported that we are getting a good response. We have 27 vendors already signed up. No public comment.
- Projects
 - O Winema Hall HVAC System/SB 5 Project CEO Munson reported that the paperwork for Pacific Power was completed and he has been pushing on CCA to get the project on schedule so it does not interfere with our spring and summer activities. No public comment.
- Funding Issues CEO Munson reported that WFA has engaged with a lobbyist in Washington DC to work on getting the two Federal bills into the stimulus package. No public comment.
