#### **SECURITY COMMITTEE** – Kim Wallis, Chair

In 2021, our Health and Safety program successfully navigated a number of challenges while dealing with changing and often confusing government COVID-19 guidelines. The record setting attendance and hot weather generated many first aid calls which were swiftly addressed by our first responders from the St. Paul Fire Department. Law enforcement issues were minimal thanks to the fine work by the Marion County Sheriff's deputies, Newberg-Dundee PD officers, OLCC Inspectors, and Creative Security. Everyone worked together to handle a wide variety of issues: bumps and bruises, heat exhaustion, lost children, seating conflicts, and the mini donkey who managed to sneak into the Tack Room at midnight on July 3rd. Our flaggers from Bell Eddy Enterprises efficiently moved hundreds of vehicles in and out of St. Paul each night as part of our city-wide traffic management plan. Thanks also, to the City of St. Paul, who help with traffic and parade control. And two weeks after the rodeo, we supported the 2021 Rose City Cowboy Classic dog show, which brought about 4,000 visitors to the grounds over the 4-day event.

But the really special kudos go to you, our SPRA members, who helped make the event a safe one by watching out for our guests, and willingly participate in the health and safety plan. Please know that those of you who reported incidents to the health and safety hotline made a big difference, and in some cases, allowed us to diffuse some potentially serious incidents.
