Visa did a great job rebranding contactless payment for Apple Pay, Google Pay, and Samsung Pay. Tap to Pay seems to be the term consumers gravitate to. I strongly encourage anyone this year who has Clover to please let your consumer know that you accept Tap to Pay with large signage. All Clover devices have the ability to accept tap to pay. Legacy Clover Station or Clover Station 2018 without customer facing display are the only exceptions. Both can have the ability added.


