



Agriscience Demonstration Event State Fair of Virginia

Contest Rules:

1. This contest will be open to FFA chapters across the state. Schools are invited to enter one or two demonstrations. If two demonstrations are entered from a chapter, each must present a different demonstration topic.

2. Demonstrations may be presented by either one individual contestant or a team of two contestants. (Note that awards are presented to a ranked demonstration, not individual contestants.)

3. Contestants must be active students in grades 6th-12th the school term preceding entry in the contest. There will be two divisions:

a.Junior Division (Division I): Student in grades 6th-9th.

b.Senior Division (Division II): Students in grades 10th-12th.

c.If either member of a team is in or above the tenth-grade level, the team will be considered Division II.

4. No individual may present the same demonstration in successive years.

5. No individual may present the same presentation as presented in the horticulture demonstration contest.

6. Presentations must be of a demonstration nature (actually doing something), not simply an illustrated talk.

7. Demonstration topics may deal with agriculture within any of the following areas: a.Plant and Soil Science

b.Animal Science

c.Agricultural Marketing & Agricultural Business

d.Natural Resources Managment & Environmental Science

e.Agricultural Engineering.

8. Fire, live animals, and operational engines may not be used during the demonstration. 9. Each demonstration is limited to 10 minutes. Following the demonstration, the judges (only) may ask questions of the contestant and only about the demonstration for up to 3 minutes.

10. Contestants must provide all equipment and materials requires for their demonstrations.

11. The contest will be limited to the first 30 teams/individuals to register in each division. 12. Power availability can usually be accommodated, but not guaranteed. Presentations that do not require power are recommended.

13. Members utilizing sharp implements must travel to and from their contest table with the sharp sheathed. Members using needles or related tools must dispose of them in a proper sharps container. Members should feel comfortable in the safe handling of these items.
