NOTICE

To All State Fair of Virginia Miniature Horse Exhibitors, Horse Owners, Grooms and Guests:

Below are three simple rules for this year's State Fair of Virginia Miniature Horse show.

All of these guidelines will be strictly enforced. Anyone not in compliance with these guidelines or any other rules set forth in the program will be removed from the show grounds immediately. No Refunds will be given and all prizes and paybacks will be forfeited. Anyone found in violation of these rules will also not be welcome back in the future!

1. **Absolutely no outside alcoholic beverages** allowed on the SFVA Grounds, to include the Equine Facilities. All alcoholic beverages must be purchased from SFVA Vendors and consumed in areas designated by the State Fair of Virginia. If found in violation you will be dismissed from the show grounds and law enforcement may be called.
2. There are many children and families at the State Fair! There will be **zero tolerance for unsportsmanlike behavior, profanity, or physical/verbal confrontations towards ANYONE.** If observed you and your animals will be immediately escorted off State Fair Property. All fees and prize monies will be forfeited. **You will not be welcomed at future shows.**
3. **No disrespectful behaviors towards State Fair staff/ volunteers, horse show staff, volunteers or exhibitors will be tolerated.** If a complaint is made or behavior is observed violators will be escorted from the show grounds, and **will not be welcomed at future shows.**

We are trying to promote a fun, family friendly environment. If you have a concern, please nicely address it with Fair/Show management and it will be addressed in a timely manner. Please help us keep Miniature Horses at the State Fair of Virginia!

We are excited for the 2022 State Fair of Virginia Miniature Horse Show.

Move in will start on Wednesday September 28th at 3pm. Our Open Miniature Horse Show to include Halter, Driving, and Performance will begin September 29th at 10 am. Our Youth Miniature Horse Show will be held September 30th at 10am.

**ALL STALLS MUST BE VACATED BY 6PM on September 30th!!
NO EXCEPTIONS! Plan accordingly.**

Due to the addition of a new pavilion near Ring 4, the Mini Show will be held in Ring 2. Please be aware that Friday September 30, is a big move in day for livestock exhibitors and a barrel race moves in and happens Friday night. Please arrive early due to extra traffic.

All horse trailers and vehicles must be parked in the designated area. **You will be unable to load/unload at the ends of the barn due to fencing.** We will try to get everyone as close to the ring as possible but you may want to show from your trailer during the show and stall your horse when not showing.

REMEMBER- Back numbers are issued to the horse/rider combos. **EACH HORSE RIDER COMBO NEEDS A BACK NUMBER.** It would be helpful if an entry form is filled out for each horse/rider combo as well.

General Rules- All Participants, Spectators.

1. **NO OUTSIDE ALCOHOLIC BEVERAGES ALLOWED. All alcohol must be purchased from approved State Fair Vendors and must be consumed in areas designated by SFVA. If found in violation you will be dismissed from the show.**
2. Owners, agents, exhibitors will refrain from any conduct deemed unsportsmanlike by SFVA or Show Staff. If found in violation you will be removed from the SFVA. Future entries to the show will be returned.
3. No Profane or disorderly conduct will be tolerated. If found in violation you will be removed from the SFVA. Future entries to the show will be returned.
4. Any abusive acts towards an animal will not be tolerated. Those who violate this rule will be dismissed from the show grounds. All fees and prizes will be forfeited, criminal charges may be sought. Future entries to the show will be returned.
5. No merchandise, tack, or animals for sale may be set up near the horse rings. The State Fair of

Virginia requires a vendor's fee. For info on vendor's permits contact SFVA.

6. Owners, agents, and exhibitors will not approach the judge without first getting the permission from the ring manager. Failure to follow this rule will result in disqualification and forfeiture of all entry fees, points, and prizes. Future entries to the show will be returned.
7. **All youth will be required to wear protective headgear (ASTM/SEI certified) in ALL classes, except showmanship.** Chin Harness must be secured and properly fitted. Adults- Helmets are optional, VCE Wavier will be required.
8. **All classes with 8 or more entries will receive paybacks**
Paybacks will be as follows
1st place- \$10.00, 2nd place- \$8.00

9. Classes are open to any miniature horse regardless of registration status. A size horses are

- 34" and under. B size horses are over 34"- 38".
Show Ponies are over 38"- 48" tall
10. Golden Age classes are open to those youngsters 50 years of age and older.
 11. Model Horse class- Horses must be at least 2 years old
 12. Miniature Horse Halter Classifications
Current Year foal - 30" & under B- Over 30"
Yearling A- 32" & under B- Over 32"
2 year old A- 33" & under B- Over 33"
3 yrs old +- A- Under 34" B- 34" & Over
 13. Novice Handler= 1st or 2nd year ever showing a miniature horse.
 14. Green Horse Division is open to all equines that fall under 48" tall. This division is open to horses in their 1st or 2nd year of showing. Those horses in their 1st or 2nd year of showing in driving classes may enter the green horse driving classes. May enter classes not designated as Mini or Show Pony.
 15. In case of an in hand high point championship tie, the horse that placed the highest in their respective obstacle in hand class will be deemed the winner of the tie.
 16. Horses and Ponies may **NOT** cross enter in the different driving categories (Open, ADS)

ENTRY FORMS/PAPERWORK- All Entries

1. Pre-entry forms and other paperwork is **DUE** by **September 16, 2021**. Any paperwork received after the due date may delay the issuance of exhibitor passes. **Make ALL checks payable to VRS 4H**
2. Entries may be made the day of the show, however to ensure easy access to the show grounds, we suggest pre-entry.

4. Entry fees will be as follows:
All classes \$10.00; **jackpot classes \$15**

To help with show preparation, please place all classes you foresee entering on your entry form. A deposit may be paid on your entry fees instead of having to pay the entire amount up front. The deposit shall consist of the following: All Stall/grounds fees, extra exhibitor pass costs and 25% of your entry fees. **WARNING! If you do not settle up at the show appropriate legal action will be taken. You may exchange or drop classes 3 classes prior to the scheduled classes with no penalty. **ALL adds, drops, exchanges must be done at the****

secretary's table located near the ring on a add/scratch sheet!

5. **Refund Policy:** Refunds on show entries will be made for horses with health reasons after a veterinarian has provided written documentation to show secretary. No refunds will be given on stall fees, grounds fees or extra exhibitor passes (that have been mailed). All approved refunds will be mailed to the payor.
6. Out of state horses will be required to have a health certificate dated within 30 days of the show, all horses must have a coggins test within 12 months of the show. Both documents must be readily available for inspection during the show.
7. Any altering, counterfeiting or forging of state health certificates or coggins tests is considered a criminal offense and will be prosecuted.

STALLS-

1. **Stall fees must be paid before occupying the stall!** The fees for stalls in 2022 will be \$40.00 per stall for the entire show, or \$25.00 per stall for one day. If a stall is occupied after the designated vacate time the responsible party may be barred from occupying a stall in 2022.
2. No stalls will be provided to an exhibitor until stall fees have been paid.
3. **If stalls are to be purchased please fill out Stall Reservation Form!** Please follow instructions on the form carefully.
4. **All stalls MUST be vacated by 6pm on Friday September 30. NO EXCEPTIONS.**
5. Stalls will be available after 3pm on September 28th. Do not arrive before then as you will not have a stall unlocked for you until after 3pm
6. Grounds fees must be paid for all horses not being stabled. The fee is \$10 per horse/day.
7. Horses staying overnight must be stabled. No horses will be allowed to remain in or be attached to any animal hauling vehicles overnight, or portable corrals.
8. There will be no smoking in the barn area by order of the fire marshal. Those in violation maybe fined.
9. No trailers or vehicles are allowed to be parked on the ends/sides of the barn at any time. Please follow parking instructions as directed by SFVA Staff. Violators may be ticketed and towed by SFVA.

Check In- All Entries

1. Stall Check in will begin September 28th at 3pm; Show entry check in will begin at 830am on September 29th and September 30th.
2. **Stalls will be assigned by the show management.** Upon your arrival proceed to the equine area gate for a State Fair Credential check. These credentials will be mailed in your exhibitor's packet. We have limited tickets so please keep this in mind.
3. **Proceed to the Secretary's office, for further instruction BEFORE UNLOADING any animals or equipment.** A note is usually posted on the booth with the location of barn manager.
4. When checking in with the show secretary, to receive your back numbers please bring the following information for verification: Coggins, state health certificate (out of state entries), if not already on file with show management.
5. Back numbers will not be issued until all required information is obtained by show secretary. No number no show!
6. **Back numbers will be issued to each horse/handler combination**
7. **All accounts must be settled within one hour of the conclusion of the show.** The show office will promptly close at that time and your account will be considered unpaid. If the owner of the horse is under the age of 18 years old, the adult responsible for the youth will be billed.

Adding/Scratching classes- All Entries

1. Any additions, changes or scratches from a class must be made 3 classes prior to the start of the class you want to change. After this time no additions, changes or scratches may be accepted and no entry fees for said class will be returned.
2. Please utilize an add/scratch sheet which can be found at the show management tent or at the announcers booth.

Ring Procedures- All Entries

1. All entries must be identified by a back number. If you do not have the correct back number you may be disqualified from the class and entry fees will be forfeited
2. The show grounds will have a PA system. This system is merely a courtesy to our exhibitors. Please be aware of when your class is. If you show up after the class is closed you will not be allowed to show and fees will be forfeited. The class will not be re-run
3. **Gate Call rule in effect!** You will have one minute to enter the ring once the last horse has entered.
4. Tack change requests must be given to the gate keeper at least 2 classes prior to the tack change

or it will not be honored. A tack change will be allotted 5 minutes maximum.

5. Breaks will be announced as needed

Show Veterinarian/Farrier

A veterinarian/farrier will be on call during the show. The numbers will be posted in the barn. Veterinary officials from the Commonwealth of Virginia will also be on site or the duration of the State Fair of Virginia.

RV/Camper Hook Ups

Available on a first come first serve basis. \$30.00/night. Contact the State Fair for more info. Tent camping allowed in campgrounds. No space will be assigned until payment is made to SFVA staff.

Trailer Parking

Ample parking for horse trailers and animal hauling vehicles will be provided near the barn area. Trailers may not be parked at the ends/sides of the barn. State Fair Credentials must be displayed at all times. Each exhibitor will receive ONE parking pass which is to be displayed at all times while in the equine area. All other vehicles must park in general parking

Exhibitor Passes

PASSES - PRE-ENTRY IS REQUIRED TO RECEIVE EXHIBITOR CREDENTIALS. Any exhibitors not pre-entered may be required to purchase a regular priced ticket each day. Exhibitor Passes will be mailed in advance to pre-entered exhibitors. **Each Exhibitor will receive 2 entry passes and 1 vehicle pass.**

The Exhibitor Passes and Exhibitor Sale tickets will be scanned daily. If you exit and plan to re-enter the equine area you will need a hand stamp. **Exhibitor credentials will provide admission to Fair only; ride wristband/tickets purchased separately.**

Pre-entered exhibitors requiring additional passes for workers may purchase a maximum of 3 Exhibitor Sale tickets for **\$20 each** dated for the same days as the show. These tickets must be purchased in advance on the entry blank. Additional sale passes will be mailed after the pre-entry deadline on a first come first serve basis. Our show is allotted a specific amount of tickets and we must ensure our exhibitors receive passes.

Driving Division General Rules

1. In case of a runaway carriage/horse, all entries will move to the center of the ring immediately and stand at a halt. Headers will be allowed in for assistance. The judge/ring steward may issue further instructions as need be.
2. Breeching, Overchecks, Sidechecks and Martingales are optional for all Driving Classes.
3. Safety Helmets are not required for drivers over the age of 18, however they are encouraged. All Youth drivers must wear a safety helmet. VCE Wavier will be required for all adults opting to not wear safety headgear
4. Classes may be combined or split based on entries/safety.
5. Horses should not be left unattended while put to a vehicle. Horses should not be left tied to a trailer, fence, stall etc... while hooked to a cart.
6. When fully harnessed to a vehicle a horse must wear a bridle with reins attached to the bit and passed thru the saddle turrets.
7. Proper Show attire is requested.
8. Open Pleasure Driving Classes- Gaits to be called: Walk, Collected Trot, Working Trot, Halt, Back
9. ADS Driving Gaits to be called: Walk, Slow Trot, Working Trot, Strong Trot, Halt, Back
10. Ties for Championships: If a tie is determined in the Driving High Point Championships, the driver who placed highest in their respective Open Driving class will be deemed the winner of the tie.
11. Novice Driver= 1st or 2nd year Showing in Driving classes.

Pleasure Driving Class Descriptions:

Open Pleasure Driving- horse shall be shown with light contact on the reins at all times. Ideally neck carriage should remain low and head set by horse being on the bit and face perpendicular to the ground. Stride should be sweeping and ground covering. Head carriage should be in the bridle, with poll not lower than the withers and eye of the horse not higher than the withers. Stride flowing with a flat knee, minimal knee and hock action. Gaits: Walk, collected trot, working trot.

ADS Style Driving: MAY NOT CROSS ENTER PLEASURE DRIVING. A Pleasure Driving class in which entries are judged primarily on the suitability of the horse to provide a pleasant drive. To be shown both ways of the arena at a walk, slow trot, working trot and strong trot. To stand quietly, both on the rail and while lined up, and to rein back. All entries chosen for a workout may be

worked both ways of the arena at any gait requested by the judge and may be asked to execute appropriate tests. To be judged: • 70% on performance, manners and way of going of the horse(s). • 20% on the condition and fit of harness and vehicle. • 10% on neatness of attire.

Obstacle Driving- Miniature Horse Obstacle Driving will be held in accordance with AMHR rules Pony/Multiples obstacle driving will be held in accordance to the American Driving Society's, Town-N-Country Obstacle Driving.

Roadster- Mini/Horse/Pony in Roadster classes must use a Roadster Cart. Proper Roadster attire is required. To be shown at the Jog Trot, Road Gait, reversed and shown at the Jog Trot, Road Gait, and shown at speed. Horses will not be asked to walk nor back.

Speed Barrel Race- Driving race. Pleasure Cart or Roadster cart may be used. Pattern will be a single barrel, down and back, 5 second penalty added for knocked down barrel. If driver is off pattern they will be disqualified. Entries may canter or use any gait at which they feel comfortable

Miscellaneous Class Descriptions/Rules

Shank-less Showmanship- Showmanship class that is performed without the use of a lead rope. Perform the showmanship class with a halter only. Neck rope may be applied, but there will be a -3 point penalty for each time the exhibitor touches the horse during the pattern.

Liberty: Your horse will be set free in an enclosed area, with no halter/bridle and demonstrate gaits at liberty for 1 minute and 30 seconds. At the end of the time period, you have 2 minutes to catch your horse and show the judge you have successfully caught your horse. To be judged on freedom of movement, use of space, change of gaits/direction, suitability of music and ease of catch.

Potato Race- There will be a start/finish line. Individual work. Exhibitor will be given potatoes. There will be 3 buckets and a barrel in a straight line, set as the course. The exhibitor must quickly drop one potato in each bucket on the way up line, go around the barrel and cross the finish line. This is a timed event. 5 second penalty for potatoes that bounce out of the bucket. No time penalty for tipped over buckets as long as the potato stays in the bucket.

Egg and Spoon- There will be a start/finish line. All exhibitors will line up at once. Will be given an egg and a spoon. Must quickly move to the turnaround point, turn around and come back across the finish line. Once an exhibitor loses their egg, they should stop in place until the completion of the class. Exhibitor that cross the line with their egg (or closest too) wins. In case of a tie, special tasks will be assigned to finalists by the judge.

Bribe A Mini Obstacle:

This is a TIMED obstacle course or pattern. See pattern for course measurements. Must follow measured or entry will be penalized. Standard AQHA Measurements to be used between obstacles. **Fastest time wins.** Must attempt each obstacle at least 3 times before moving to next obstacle.

The object is to see who has the greediest pony. You do this by leading your horse without touching it through a pattern using a bucket of treats or grain.

Precision is NOT JUDGED. If you need to weave through cones, it doesn't matter which side you start on. You don't need to be centered on a tarp or bridge and you can go on them also.

1. Unclip lead rope from horse. A neck rope may be worn by the horse (just in case if needed). Time starts when you start over the starting line.

2. You may not touch your horse. **Each time** you touch your horse or the neck rope (if applicable) that's a **5 second penalty.**
3. You must give an honest attempt at every obstacle. Try three times before moving on to next. Failure to do so will result in 10 second penalty for each obstacle not attempted 3 times.
4. You may not give your horse any treats until they have completed the course.
5. Complete the course in order.
6. You must stay in front of or beside your horse at all times.
7. You must cross the finish line in front or beside your horse or you will be disqualified. They cannot beat you across the line.

Carrot Race- All Exhibitors in the class will line up at start line. They will quickly run down to their assigned spotter who will provide a carrot/treat to the exhibitor. The exhibitor will feed the treat to the horse, once horse has eaten the treat the spotter will tell exhibitor to head to finish line. Placed based on who crosses the finish line the fastest. If a horse drops the treat out of their mouth they are disqualified. If exhibitor drops the treat, they are disqualified.

PARTICIPATION AGREEMENT AND ACKNOWLEDGEMENT OF RISKS

THIS IS A LEGALLY BINDING CONTRACT. THIS DOCUMENT PROVIDES THE TERMS AND CONDITIONS UNDER WHICH YOU WILL BE GRANTED PERMISSION TO PARTICIPATE IN CERTAIN EVENTS. PLEASE READ CAREFULLY.

Agreement: I desire to participate in one or more equine and/or agricultural and livestock events (“Events”) at the State Fair of Virginia, which is owned and/or operated by Commonwealth Fairs & Events, Inc. and/or State Fair of Virginia, Inc. (collectively, “State Fair of Virginia”). I understand that my participation in the Events is conditioned upon my agreement to the terms and conditions set forth herein, and I further understand that my agreement to these terms (along with any entrance fee charged for my participation in the Events) is intended to act as legal consideration for my participation in the Events. I further understand that my execution of this Participation Agreement and Acknowledgement of Risks (“Agreement”) is voluntary, and if I choose not to execute this Agreement, I will not be allowed to participate in the Events.

Definitions: The Events covered by this Agreement include, but may not be limited to: the 1st Virginia CMSA; ; Draft Horse/Mule Show and Pull; Miniature Horse Show; Dressage Show & Demos; Roping, Youth Barrel Race; True Grit Ranch Rodeo; 4-H Drill Competition; 4-H Ranch Horse Show; 4-H Fun Show & High School Rodeo.

Acknowledgment of Risks: I am aware and acknowledge that participation in these Events poses potential serious risks of injury or death to participants, and I am aware of the inherent dangers of equine sports and/or activities involving livestock. These risks include, but are not limited to: risks involved in riding (such as falling or being thrown from a horse) or dealing in close proximity with large animals (such as colliding with an animal or being trampled, stepped on or bitten); risks of failure or misuse of equipment such as saddles, riding gear, fences, jumps, rifles, trailers, and other items; risks associated with the facilities and property upon which the Events are held, such as uneven land, debris, holes, mud, weather conditions, and/or improperly designed, maintained or repaired fences, gates, jumps, etc.; and the risk that another participant might act in a negligent manner that may contribute to cause an injury to me. I understand that this list is illustrative, not exhaustive, and that various other risks are inherent in the Events in which I am going to be engaged. I understand that I may be injured or die as a result of my own negligence, the negligence of others, or through no fault of myself or anyone else, because of the nature of the Events in which I am going to be engaged. **Accordingly, I knowingly and freely assume all risks, including but not limited to the risk of bodily injury, death or property damage, both known and unknown, associated with my participation in the Events and my use of facilities and equipment owned, operated, maintained or provided by the State Fair of Virginia. I assume full responsibility for my participation in the Events and my use of such facilities and equipment.**

Compliance with Rules: I agree to comply with all rules, requirements, and regulations of the State Fair of Virginia as well as all requests and instructions of all State Fair of Virginia personnel. I agree to use reasonable judgment while participating in the Events to ensure my own safety and the safety of those around me, and I agree not to participate in any Events while under the influence of drugs or alcohol.

Release: I, for myself, my spouse, my heirs, assigns, personal representatives and next of kin, do hereby forever discharge, release, indemnify and hold harmless the State Fair of Virginia and all of its affiliates, subsidiaries, sponsors, contractors, licensees, employees, agents and representatives, from any and all claims, demands, damages, losses, actions, suits and/or proceedings, whether sounding in tort or contract, whatever kind or nature, whether present, future, known or unknown, foreseen or unforeseen (including, but not limited to, claims for personal injury, death, disability, and property damage), relating to, arising out of or regarding or as a result of my participation in the Events, or in any activity sponsored by the State Fair of Virginia, regardless of whether the act or omission complained of was caused in whole or in part by my own acts or omissions, the acts or omissions of any third parties, and/or by the acts or omissions of the State Fair of Virginia, or its agents, to the fullest extent permitted by law. I further release the State Fair of Virginia from any claim whatsoever on account of medical treatment or service rendered me during my participation in the Events and/or my use of the State Fair of Virginia’s facilities and/or equipment.

Right to Use Image: I grant the State Fair of Virginia permission to use my photographs, video images and/or quotes in any State Fair of Virginia publicity pieces. Publicity pieces include (but are not limited to) news releases, videos, publications, displays, newsletters, brochures, and internet use. All proprietary rights to the aforementioned media belong exclusively to the State Fair of Virginia.

Duration: This Agreement shall expire upon the completion of my participation in the Events. However, the acknowledgement of risks and release provisions in this Agreement shall remain valid and enforceable for a period of five years after the completion of my participation in the Events.

Governing Law and Venue: I further agree that any litigation arising out of my participation in the Events shall be decided under the laws of the Commonwealth of Virginia, and such litigation shall be brought in the Circuit Court for Caroline County, Virginia.

Voluntary Execution and Severability: I have carefully read this Agreement, fully understand its terms and conditions, understand that the terms and conditions are contractual and not a mere recital, that my execution of this Agreement is consideration for and a prerequisite to my participation in the Events, that I have given up substantial rights by signing it, and I sign this Agreement freely and voluntarily as my own free act without inducement. In case any one or more of the provisions contained in this agreement shall, for any reason, be held to be invalid, illegal or unenforceable in any respect, the invalidity, illegality or unenforceability, shall not affect any other provisions of this agreement, and this agreement shall be curtailed, limited or eliminated only to the extent necessary to remove the invalidity, illegality or unenforceability.
