Call to Order:

Chairperson Spicer called the meeting to order.

Roll Call:

Approval of Agenda:

Trustee Zotti moved to approve the agenda. The motion was seconded by Trustee Torgersen. Motion passed unanimously.

Approval of Minutes

Erika Koshar reviewed the July 2020 events.

Spicer inquired if the Speedway has been well attended. Pendleton noted that all races thus far has been sold out for spectators and the car count has been hirer than ever before.

Old Business:

<u>Water Metering Station & MOU with City of Rock Springs</u> – Executive Director noted that the agreement has been signed and being sent to the City.

<u>FY 2021 Budget</u> – Executive Director Lloyd noted that the budget has been approved by the County Commission. The total will be \$703k less than requested. Trustee Spicer inquired what will change. Lloyd noted that the rental and gate fees will increase in order to cover the costs of putting on the event. One comment Lloyd has heard, "The SEC needs to be more self-sufficient". Our rates are kept low because we receive money from the mill levy.

For example, the Indoor Arena doesn't charge for general usage, however, we maintain the ground, and facility. There may be usage fee now associated to any riding. SEC has to take a strong look at the costs of running an event and usage.

Trustee Zancanella noted that it will be extremely difficult for the community because our users are spoiled as they want the arenas and track worked. We are cutting back the use of our fuel, usage of the harrow teeth and wear & tear of machinery.

Director Lloyd noted that we have difficult conversations to have in the next week in regards to labor in regard to who stays and who goes.

It starts at the County Commission level, if they don't want to fund us, we are going to have to find alternatives.

SEC provides the number 1 recreation outlet for Sweetwater County. Those who cannot take a camper to the mountains, they come out to the complex to blow off some steam.

Entities like the School District, who have taken advantage of our deep discounts for youth events are going to need to pay full rental rates. Especially since these events usually require more setup.

Currently, we get calls and inquiries on a daily basis for teens needing a place to work. We typically hire 54 seasonal positions and many are still not employed.

Commissioner Lloyd noted that it was difficult and quite convoluted overall. He looks forward to the first strategic planning meeting & discussion on June 18th so that we can add budget discussions throughout the year.

Kandi Pendleton noted that Bonnie Berry made a public comment during the budget public meeting noting her disappointment in the Commission for choosing objects over people.

<u>Live Horse Racing</u> – Kandi Pendleton noted that contract is complete. We currently don't know what it will look like exactly, but no spectators. The races will run Sunday, Monday & Tuesday to continue the simulcast. We struggled with this process, but we need to have the space for a jockey changing room, which closes off the facility to the public.

<u>Fair 2020</u> – The Board was provided a schedule for the week of the Sweetwater County Fair. We are not allowing the beef to tie out in the east arena. The beef and sheep will be housed in the stall area. The only shavings provided will be for the livestock auction. Erika is recycling some awards to prepare for the 4-H events. The horse ring will stay up all week as we do not have the manpower to switch it around. Trustee Zotti noted that many 4-H families have asked for the event to be wholly focused on the kids' projects and this is the year to see how it works. Trustee Spicer reminded the Board that no entertainment or family activities during the project showings. Pendleton noted that we are asking the 4-H kids to clean their stalls before premiums will be paid.
