MUTTON BUSTIN' RULES

1. THE CHILD MUST BE BETWEEN THE AGES OF 4 AND 8 (AS OF JAN.1<sup>ST</sup>)
2. THE CHILD MUST WEIGH LESS THAN 60 POUNDS.
3. THE CHILD AND PARENT WILL ENTER THE MAIN PARKING LOT OF THE FAIRGROUNDS AND BE AT RODEO GROUNDS NO LATER THAN 7:00 P.M. ON DATE ASSIGNED FOR COMPETITION. ANNOUNCEMENTS WILL BE MADE FOR PARTICIPANTS TO COME DOWN TO ARENA. PARTICIPANTS WILL MEET ON THE NORTHWEST END OF THE OVERHEAD STAIRWAY DURING SADDLE BRONC RIDING.
4. PARTICIPANT WILL BE REQUIRED TO USE A "WOOL HOLD." BELTS, ROPES, OR OTHER DEVICES WILL NOT BE PERMITTED.
5. PARTICIPANT MAY USE ONE OR TWO HANDS. POINTS WILL BE ADDED FOR RIDING ONE HANDED.
6. ONLY ONE HELPER PER CONTESTANT WILL BE ALLOWED IN THE CHUTE AREA.
7. CONTESTANTS MUST DRESS WESTERN.  
(LONG SLEEVED SHIRT, WESTERN BOOTS, WESTERN HAT.)  
HELMETS WILL BE PROVIDED WHILE RIDING SHEEP
8. SPURS ARE NOT ALLOWED.
9. CONTESTANTS WILL BE SELECTED ON AUG. 28<sup>TH</sup>, AT WEDNESDAY NIGHT QUALIFER. NO MORE THAN (10) CONTESTANTS PER RODEO NIGHT WILL BE ACCEPTED.
10. ANY VIOLATION OF THESE RULES WILL RESULT IN DISQUALIFICATION.
