

## Trinity Valley Exposition TVE Pageant 2021

- All contestants must be female and 3-13 years of age on or before the date of the pageant: **October 16,2021**.
- Proof of age is required, a copy of birth certificate must accompany entry form and entry fee.
- Each contestant must reside in one of the following counties: Liberty, Chambers, Jefferson, Hardin, Polk, San Jacinto, Montgomery or Harris County.
- Entry fee is \$30 per contestant.
- Each contestant must submit a 4" x 6" headshot to be eligible for the photogenic category. Photo **MUST** accompany this entry form to be eligible. No photos will be accepted the day of the pageant or after the entry deadline.
- Western wear is required to be worn by each contestant.
- There **WILL NOT** be a talent portion of the competition. Any talents presented before the judges will not be recognized in the contestant's overall scores.
- Each contestant will only be judged on **personality, stage presence, conversational skills and overall appearance**. All scores will become property of the Trinity Valley Exposition. No scores will be made public.
- Only one parent/guardian may accompany child on stage should they require assistance.
- There will be no refund of any entry fees once they have been accepted. If contestant fails to show up or chooses not to compete once pageant begins, they will still receive a participation award but no entry fees will be returned.
- Contestants are only eligible to win one category in their division.
- Each contestant who participates will receive a participation award.
- The winner of each age group will receive a buckle, sash, flowers and tiaras
- The contestant who places runner up in each age group will receive a trophy, sash and assorted prizes.
- The winners of the photogenic contest of each age group will receive a trophy and sash.
- TVE will provide a float for the opening day parade held on Wednesday. All winners are encouraged to attend. All winners are welcome to enter the local parades throughout the 2018/2019 year using their title won.
- **No entries will be accepted after the October 13th, 2021 deadline.**

- All decisions by Judges and Pageant Chairmen are firm and final.
- Pageant will begin at 2:00PM on October 13<sup>th</sup>, 2021 at the TVE Fairgrounds. Please check in one hour prior to event. Late contestants will be disqualified unless Pageant Chairman gives approval to allow continuation of competition upon arrival.
