I understand that as the Amarillo Tri-State Fair & Rodeo Queen, I am an official representative and responsible for representing the Amarillo Tri-State Fair & Rodeo and the sport of rodeo in its best and truest light to the best of my ability. I will strive to represent unexcelled sportsmanship, high moral and ethical standards and humane treatment of animals.

As a representative of the Amarillo Tri-State Fair & Rodeo, I will speak, act and dress according to the esteem the title of Queen deserves. I, as the Amarillo Tri-State Fair & Rodeo Queen, understand I will not receive a salary, and all travel expenses throughout my reign will be at my own expense.

### **When is the Tri-State Rodeo Queen Contest?**

The contest will be held in the Amarillo National Center on Saturday, September 7, 2024, with times TBD. The awards ceremony will follow the contest.

### **Who can participate in the Amarillo Tri-State Fair & Rodeo Queen Contest?**

Any female born young lady who follows meets the following qualifications:

1. Wishes to be a representative of the community and professional rodeo along with having an experienced understanding of all things the western way.
2. Carries themselves in an intelligible and well-spoken manner.
3. Ages 15-18 at the time as of January 1, 2024.
4. Has the ability to ride and provide their own horse.
5. Be a legal resident of the United States and live within 200 miles of Amarillo, TX.
6. Be a student in good standing, if applicable.
7. Not be, have been or become married, nor have had a marriage nullified.

### **As the Amarillo Tri-State Fair & Rodeo Queen Contest Committee, we will:**

1. Provide \$2000 Cash Scholarship, paid upon the conclusion of 2024 Amarillo Tri-State Rodeo reign.
2. Provide Queen's Crown and chaps, to be passed to future Queens.
3. Provide Queen's Trophy Buckle and Sash.
4. Provide Calendar of Events as early as possible that we wish for Queen to attend.
5. Provide additional prizes at the Queen ceremony.

### **As the Amarillo Tri-State Fair & Rodeo Queen, I will:**

1. Wear my crown, hat, sash, and buckle anytime I am acting in the capacity of the Amarillo Tri-State Fair & Rodeo.
2. Make myself available to the Amarillo Tri-State Fair & Rodeo for media interviews & appearances the week of September 13-21, 2024.
3. Attend all Amarillo Tri-State Fair & Rodeo PRCA performances September 19-21, 2024, ride in the parade on Saturday, September 14, 2024, and assist with Mutton Bustin' qualifications.

4. Avail myself of all opportunities to make appearances on behalf of the Amarillo Tri-State Fair & Rodeo and be prepared for autograph signings, photographs, and media interview opportunities to promote the Amarillo Tri-State Fair & Rodeo, the sport of rodeo, and the agriculture industry as a whole. I understand if I attend any PRCA rodeo as a queen during the year of my reign, I must attend as Miss Amarillo Tri-State Fair & Rodeo unless prior permission is given.
5. Attend a minimum of 5 additional promotional appearances representing Amarillo Tri-State Fair & Rodeo throughout the year. I understand that two of these appearances must be during the second half of my reign. Additional appearances may be requested and/or offered by the Tri-State Fair & Rodeo. Title holders are not limited to the above representations.
6. Care for and maintain the crown and chaps that will be used during my year of reign. If lost or damaged, I understand I will be charged for replacement or repairs.
7. Be prompt for all appearances.
8. Agree that during my reign, I will remain unmarried, without children, and observe high standards of moral and ethical behavior befitting my title of Amarillo Tri-State Fair & Rodeo.
9. Observe tasteful social media posts refraining from the use of profanity, vulgarity, and nudity. I give permission for my image to be used on all media associated with Amarillo Tri-State Fair & Rodeo.
10. Attend and participate in the 2025 Amarillo Tri-State Fair & Rodeo and crown the new Queen.

I understand that any violation of these above-mentioned could result in the loss of my title as Miss Amarillo Tri-State Fair & Rodeo Queen. I also understand if I am unable to fulfill my reign, the Amarillo Tri-State Fair & Rodeo reserves the right to name a successor, and I must forfeit & relinquish all awards and reimburse the Amarillo Tri-State Fair & Rodeo for all monies and items awarded as Miss Amarillo Tri-State Fair & Rodeo.
