MISS TULELAKE/BUTTE VALLEY COMPETITION DESCRIPTION

ELIGIBILITY:

- Residency: All contestants must have RESIDED in the 10-A District at least the past 6 months.
- Age: Contestants must be Sophomores or Juniors in High School at the time the application is due, and age 16 or older (by first date of fair).
- Other: Contestants must be single, (never married), never been a parent (never pregnant) and female. Contestant must be able to provide her own transportation at least to and from the fairgrounds in Tulelake.

GENERAL RULES:

- Application: All applications (pages **2 & 3** of this packet, **2 photos** to be used in the newspaper, **transcripts** of previous two years, and **2 letters of recommendation**) must be submitted to the Fair Office (by mail or in person) by February 13, 2025.
- Process: Applications may be screened. Judging interviews will be held at the Tulelake Butte Valley Fair Office on February 16 at 5:30 pm. Miss Tulelake and Miss Butte Valley may be chosen to represent the Tulelake-Butte Valley Fair at the Dorris 4th of July celebration along with other various fairs/parades through out the summer, and act as the official hostesses of the Tulelake-Butte Valley Fair on September 4-7, 2025. Fair Court clothing (ex.: dress, shoes, jacket, pants, shirt) will be purchased under the supervision of the Fair Court Committee. The fair court will get to keep these items. Each girl will be provided with a tiara and sash. Fair Court members shall at all times conduct themselves in a friendly, courteous and appropriate manner. After proof of college attendance (after at least 1 semester), a scholarship (\$500) will be awarded to each Fair Court member. Miss Tulelake and Miss Butte Valley are also eligible to complete in the Miss California State Competition should they choose, however, the Tulelake-Butte Valley Fair is not able to assist them financially.

Poise & Posture.....	20%
Communication skills	25%
Social responsibility (activities: fair, community).....	25%
Academic Achievement	10%
