Attached, you will find the Fair-Time RV Park Application for the 2025 Fair Season and the rules and regulations for the camping space area. Please note the following highlights:

- The RV Spaces with hook ups in the RV Park area are for Vendors and Livestock Exhibitors ONLY.
- RV Camping sites with hook ups are assigned with the priority being:
 1. Commercial Vendors/Food Vendors
 2. Market Livestock Exhibitors from the Butte Valley Area
 3. Market Livestock Exhibitors from the Newell/Tulelake Area.
- **We will accommodate as many as we can, but when we run out of RV spaces with hook ups, RV's will be assigned to a dry camping space**
- We have a large dry camping area that is available to anyone who would like to camp and will accommodate overflow from the RV parking lot. Any extra trailers/cars/trucks must be parked in the field parking lot south of the fairgrounds.
- Please return completed applications to the fair office by **May 9, 2025** WITHOUT payment. Your payment will be requested and processed if your application is accepted.
- Spaces will be assigned according to length and width. We will place two RV's in one space whenever possible. There are separate 30amp electrical hookups for each RV, but water and sewer service is shared.
- You MUST check in with the RV Host **BEFORE** parking your RV in your assigned space. If changes are to be made the RV host must first notify the office and an approval must be given.
- **NO VEHICLE PARKING** allowed in the RV area.
- There is free parking outside the RV park gates and in the grass lots around the grounds (excluding VIP & VENDOR parking lots).
- **Tent Camping—Please contact the office to make arrangements.**

Complete and return the enclosed application and return with the applicable fees as soon as possible. Spaces will not be reserved without the completed forms AND until full payment is received. Once your application is processed, you will be sent a contract to complete. If we are unable to process your request for camping, you will receive a refund.

The camping area fees for the 2025 fair are as follows:

Full Hook-up Camp site	\$200
Partial hook ups, no sewer (maximum 25' in length)	\$150
Dry camping.....	\$75 for the week or \$20 per night
Supply Storage Trailer/Van	\$100

2025 RULES AND REGULATIONS FOR FAIR-TIME CAMPING SPACE

1. **Registration:** All persons wishing to stay on the fairgrounds must register by completing a contract with the fair office. Spaces will not be reserved without payment or without length and width of the vehicle specified.
2. **Parking/Setup:** Starting Sunday prior to the fair opening, recreational vehicles will be brought in through RV Gate beginning at 8:00 am, unless other arrangements have been made and approved by the CEO of the Fair association in advance.
 - a. **DO NOT** park without the campground attendant or someone from the office giving you permission.
 - b. The campground attendant has the right to assign spaces and change any assignment as the person best sees fit.
 - c. Recreational vehicles will be assigned a specific location and must stay there for the duration of the fair.
 - d. RV Parking permits will be distributed upon entering and setting up. This permit must be in a visible location on the recreational vehicle at all times.
 - e. All recreational vehicles must park parallel to and within the markers of the assigned space.
3. **Length/Width of RV:** No recreational vehicle may go over the allotted length/width allowed in a space due to fire lane restrictions. The total length and width (maximum space to be used) must be accurate on the front of the application or you may be asked to camp in the dry RV camping lot
4. **Vehicles:** No vehicles will be allowed to park in the RV Park. All illegally parked vehicles will be cited and removed by the fairgrounds.
5. **RV PARK GATE:** The RV Park gate will only be open to vehicle traffic during move in. Beginning Thursday of the fair the gate will remain as a walkthrough gate only unless you are approved by the camp host to drive in to drop things off and leave right away.
6. **Storage Trailers & Storage Vehicles:** You may be able to purchase a parking space to park a supply storage trailer/van/vehicle in the RV Lot w/o any electrical hookups.
7. **Feed Trailers:** Will be placed along the inside of the fence on G St. Please call the fairgrounds for details.
8. **Liability:** Areas are to be kept clean and fire-hazard free (no open flames). The 10-A District Agricultural Association/Tulelake-Butte Valley Fair is not held liable for any theft or property damage that occurs in the RV Park area. There are no dogs allowed in the RV Park unless it has been approved by Fair Management. There is NO ALCOHOL allowed on the fairgrounds. Violations will be handled by the fairgrounds security and law enforcement with immediate expulsion from the fairgrounds.
9. **Curfew:** All persons who remain on the fairgrounds at night must be in their RV by midnight. No disturbances will be tolerated. Violators of this rule will be removed from the grounds and their premiums withheld, if applicable. There must be an adult of at least 25 years of age staying in each recreational vehicle each night.
10. **After Fair:** all RV's must be removed from the fairgrounds by the Monday following the fair unless approved by fair management.

NOTE: The fair maintains a zero-tolerance policy regarding minors in possession of alcohol and drugs. All violators will be removed along with their livestock and any premiums will be forfeited.
