Please complete the attached Oklahoma Tax Commission State Fair Registration Form 827-T and return it to the Oklahoma Tax Commission no later than August 1, 2022. This is a fillable form designated specifically for the Oklahoma Tax Commission (OTC) and separate from your State Fair registration. Therefore, please complete all of the information on the form. Every vendor must complete Form 827-T for the OTC. If you are not selling any product or service, please indicate this on line 4. Also, if you hold a valid Oklahoma Sales Tax permit, include your sales tax permit number on line 10. Be sure to include a current phone number and email address. Vendors must be compliant with Oklahoma State Tax Laws before vendor move-in to the Tulsa State Fair will be allowed. Once your registration with the Oklahoma Tax Commission has been processed, you will receive an email notifying you whether or not your registration is approved.

Notice: Your Sales Tax Return and payment MUST be filed and paid online at oktap.tax.ok.gov. You must provide confirmation numbers for both the filing and payment to the Oklahoma Tax Commission representatives in the OTC office at the fairgrounds on Saturday, October 8 or Sunday, October 9. NO CASH payments will be accepted.

Please return Form 827-T directly to the Oklahoma Tax Commission as it is processed separately from your Tulsa State Fair registration. If you have any questions or concerns, please contact us at the information below.
