**Hours of Rental:** The Fairplex Facility is available for rental (Sunday – Saturday), 6am – 12am. Events must end in accordance with the contracted end time.

**Deposit:** A damage deposit in the amount of \$450 is required to reserve date. If rental fee equals \$899 or less, deposit will be 50% of that fee. No date reserved without signed Fairplex Rental Agreement and required deposit from Lessee.

**Early Access Fee:** Lessee shall setup, decorate, takedown and clean during the hours specified in the signed contract. Early access for purpose of decorating/setup may be granted up to 18 hours prior to the contracted rental time by paying the Early Access fee of \$350. Early Access Fee must be paid in full 30 days prior to event date.

**Security:** Lessees contracting private events having more than 100 attendees and/or having alcohol present must provide security at Lessee's expense by contacting the Uvalde County Sheriff's Department at 830-278-4111. Security must be arranged/paid 30 days prior to event date. For public events not selling or providing alcohol, security may not be required, however, Lessee will bear full responsibility for attendees.

**Insurance/Alcohol Sales Fee:** Proof of Insurance required 14 days prior to event dates of those events **selling** alcohol and/or public gated events. No less than \$1,000,000 Liquor Liability Insurance Policy required for events selling alcohol. **All events selling alcohol will be assessed a \$500 Fee.**
