#### Directions:

- **From North or South via Hwy 12:** take the US-12BUS/South Blvd ramp exit on to Business Hwy 12, at the traffic circle, take the 1<sup>st</sup> exit onto US-12 BUS/County Rd W continue through two traffic circles, turn right at the stop light next to the Napa, on to Water St. (Hwy 113.) Continue on Water Street (through one stop sign, and a few blocks down, Driftless Glen will be on the right (south side).
- **From East via Exit 106, Interstate 90/94:** Follow State Hwy 33 West towards Baraboo (approx. 17 miles) As you come into Baraboo, take the second street to the left (south) Washington Avenue. Follow Washington Avenue to Water Street (Hwy 113), Go Right (West) on Water St. travel 0.6 miles and Driftless Glen will be on your left.
