

# MESSAGE

The 2014 Washington State Fairs Association (WSFA) convention is behind us and it was another superb opportunity for our member Fairs to come together for great presentations,

education, competition, entertainment, trade show and lots of fun. Year-to-year that does not change, and will remain our focus. But there are significant challenges in the immediate future for each of us, not only your Association Board of Directors, but for every member Fair in WSFA. The challenges we have been handed are serious and will require an effort on the part of each of you, individually, and corporately as Fairs and events. It will require the support of your participants, volunteers, staffs, community leaders and elected officials.

The number one priority I see right now is mounting a state-wide effort to restore the full Fair Fund. As you know, the fund was zeroed out in the budget proposal from the State Department of Agriculture that the Governor asked for in response to the funding mandates in the McCleary basic education decision from the Washington State Supreme Court. The Fund was in the standard budget prepared by the Department but cut from the budget proposal which reflected a 15% general fund cut to satisfy the McCleary mandates. When the Governor's budget was release last month it did contain an increment of funding for Youth Fairs. That is a positive from where we started. We faced a similar threat in 2010 when the Governor sought to eliminate Fair funding and we were successful in making the case

for Fairs, youth, education and economics. We can do it again .

What should we be doing now to increase our chances of getting the whole Fair Fund restored in the budget? Of primary importance, set aside January 29th 2015 on your calendar to join us in Olympia for WSFA Legislative Day. This is our opportunity to meet en masse and visit as many Representatives and Senators as we can and educate them on the purpose and value of the Fair Fund to the youth and constituents in their legislative district. Numbers count and voices are listened to. Your Board will be there but you are in the best position to tell your Fair's story. One very important question you should be prepared to address is "What would be the impact on your Fair without the Fair Fund?" That is the piece of the story that only each individual Fair can answer Our lobbyist, Heather Hansen, has done an excellent job of putting together information for you to use in this effort. When you come to Olympia we will have handouts for you, and remember that bringing youth affected by this possible cut is a very powerful message. These young folks have helped in the past and they are articulate spokespersons for Fairs.

We have all been down this path before and know it well. This is not an annual "the sky is falling" though. This is as serious as it gets when we have to start from a position of not being in the budget at all and needing to get in the front door so we have something to defend. If you need more information, call or email your WSFA Board member. We are all here to serve you individually as well as corporately for the betterment of Fairs across the state. The Board has worked hard to ensure we are a strong voice in Olympia on every matter affecting Fairs.

# The Fair Fund is Empty – your help is needed to fill it up

When Governor Inslee released his budget proposal in preparation for the 2015 legislative session, it did not include funding for Fairs. If we are to be successful at getting the Fair Fund back, we need participation by volunteers,

4-H leaders, youth exhibitors, and community leaders.

Please reach out to everyone involved with your fair, from youth participants to community groups and ask them to contact their legislators. Legislators need to hear from constituents about how important the fair is to families and your community.

Each person has three state legislators, two representatives and one senator. You may contact them via email or US mail.

# Ideas to help you write your letter

The Fair Fund was created in 1961. It supports 33 county fairs, 4 area fairs, 12 youth shows and 17 community fairs across Washington. When the Fair Fund was moved into the general fund in 1998, it was cut in half. The remaining \$2 million per year has never been increased.

Youth shows and small county Fairs rely on the fund for up to 80% of their total budget. Of the 66 fairs supported, 25 derive over 30% of their annual budget from the Fair Fund. (All youth shows are operated under the auspices of either WSU or OSPI.) Without this support, many may not continue to operate.

Education comes in many forms. Through 4-H, FFA and other youth programs, fairs provide the opportunity for youth to learn responsibility, record keeping, public speaking, teamwork, social skills and much more. The Fair also provides recognition of year-long learning efforts. This real world recognition for work invested is a significant lesson in workforce preparation. In addition,

many fairs coordinate educational programs with local schools.

Studies show that youth who participate in Fairs are nearly twice as likely to do well in school, twice as likely to go to college, 40% less likely to engage in risky behaviors and 25% more likely to contribute positively to their families and communities.

Note: Payments to Fairs in the spring of 2015 will not be affected. This budget affects payments for 2016 – 2017.
