

WCFA Jr Quilt Show Rules

Quilt Divisions:

- **Category 1 Kit:** Quilt Kit includes pattern & fabrics; quilter may add additional fabrics. WCFA Jr Quilt Show Entries may be sub-divided into classes, at the discretion of contest officers.
- **Category 2 Non-Kit:** Quilt made from a pattern or original design; **fabrics must be selected by quilter**. WCFA Jr Quilt Show Entries may be sub-divided into classes, at the discretion of contest officers.

*Quilt sizes should be no less than 36" (± 1 ") width + length of quilt (i.e. 18" X 18" mini quilt) and not to exceed 110" (± 1 ") width + length of quilt (i.e. 50" X 60" lap quilt).

1. The Junior Quilting Division is open to Walker County youth who are members of FCCLA, FFA, or Walker County 4-H Quilting Club and are in the 3rd-12th grade. Each exhibitor must meet their program requirements, activities, or meetings set by their Program Advisor and must have participated in at least 2 content related activities/meetings.
2. Student will enter according to grade level as follows:
 - Junior – 3RD to 5TH Grade
 - Intermediate – 6TH to 8TH Grade
 - Senior – 9TH to 12TH Grade
3. Guidelines for Quilted Items:
 - A quilted exhibit consists of 3 or more layers.
 - All quilted items must be quilted (by hand or machine).
 - All quilt piecing and finishing must be the sole work of the Jr Quilter. Including quilting – whether machine or hand quilted.
 - No pre-quilted fabric may be used.
4. Contestants may only enter one quilt and quilt entry must have been constructed between the previous Walker County Fair Dates and the upcoming Walker County Fair Dates. No previously entered items may be entered.
5. **A completed WCFA Entry Form and non-refundable entry fee of \$5.00 is due** at the non-livestock sign-up to be held at the **Walker County Fairgrounds, per the date scheduled by the Walker County Fair**, will be the only date on which Fine Arts entries will be accepted.

6. Entry items (quilts) **are due** to Fabric Carousel, the **Tuesday before the opening day of the Fair by 5:00 p.m.**
7. Each quilt **MUST** have a 4-inch finished, casing (sleeve) the full width of the top edge of the quilt back, securely stitched or attached with safety pins at the top and bottom. Quilts measuring 24 inches or less **MUST** have a 2-inch casing. Quilts without a casing will not be accepted.
8. Quilts **MUST** be labeled in the bottom right corner of the back. The preferred label is fabric with the information clearly printed on the label. Clearly visible embroidery is acceptable.
 - Name of Quilt
 - Name of Quilt Maker
 - Completion Date
9. Workmanship and Showmanship judging is not open to the public. Showmanship judging will be at 1:00 p.m. on Tuesday, the week of the Fair. The WCFA Jr. Quilt Show and Awards Ceremony will be at 4:00pm or follow immediately after the Style Show and Awards Ceremony.
10. Awards: Workmanship and Showmanship awards will be given in each age group. Overall Grand and Reserve Champions will be selected (combined highest score of workmanship and showmanship), for each age group.
11. All Junior Quilting Division Quilts will stay on display at the Walker County Fairgrounds, through the closing of the Fair. Arrangements will be made as to when to pick up the quilts.
12. Quilts will not be available for sale
13. Judges' decisions are final, no grievances may be filed.
14. Dates and times may be subject to change and exhibitors will be notified via electronic communication.
15. A junior quilt project that is being shown in the Walker County Fair Junior Quilt Show is not eligible to be shown in the Walker County Fair Quilt Show, during the same year, but is eligible to be shown in the Walker County Fair Quilt Show, one time, within the next three consecutive years.
