

# Agreement to Participate: Assumption of Risk and Release

## Registration Fee per child \$20.00

In consideration for allowing my child, \_\_\_\_\_, age \_\_\_\_\_, to participate in the Walker County Fair Association Mutton Bustin', I hereby acknowledge that my child's participation in the Mutton Bustin' event and related activities is expressly conditioned by my representation in this release. I, individually and as the representative for my child, do hereby release and discharge the Walker County Fair Association, their officers, members, employees, agents, volunteers, attorneys, accountants, sponsors and advertisers from all liability or responsibility directly or indirectly related to the Mutton Bustin' event and related activities which could be hazardous and dangerous to my child, my child's property, other persons in my group, or the property of others, including without limitation, all activities which will or could occur in and around the rodeo arena. My release and discharge of the released persons covers and includes, without limitation, any claim, right, cause of action or lawsuit by reason of any injury (including death) to my child or my child's property or the property of others irrespective of how such injury or damage may be caused. I understand and acknowledge that the activities that my child may engage in are inherently dangerous and hazardous and will involve inherent unpredictable and dangers nature of animals in a rodeo arena environment. I understand that my child's participation in these activities is expressly conditioned upon and subject to my full acknowledgement and appreciation of both the risk of harm and adequacy of this warning. I further understand that the released persons are relying upon my representations that I acknowledge the adequacy of the warning and appreciate the risk of harm. I understand that during my child's participation in these activities, the negligence of other persons may cause serious injury or death to my child or damage to my child's property or the property of others even though these other persons are being reasonably supervised.

Mutton Bustin' participant expressly agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Texas and is intended to include a release of the indemnities for their own negligence. If any portion of the agreement is held invalid, it is agreed that the balance shall continue in full legal force and effect.

Mutton Bustin' participant affirms that Mutton Bustin' participant representative has carefully read the above release, knows the contents of the release and signs this release as Mutton Bustin' participants own free act. This release contains the entire agreement between the parties to this agreement and the terms of this release are contractual and not a mere recital.
