



# Camping & Stalling Rules



1. Camping stay is for arrival date to departure date only.
2. MAXIMUM STAY 7 NIGHTS.
3. Payment and forms, including signed waiver, must be received prior to any stay.
4. Payments must be current for any stays.
5. The Fairgrounds is zero tolerance crime.
6. Must follow WW County noise ordinance.
7. Be courteous, be respectful, be kind. There may be other campers as well as the neighbors around the grounds.
8. No excessively loud radios and/or TVs.
9. No alcoholic beverages allowed outside of RV. Follow State laws and regulations.
10. No marijuana use allowed on grounds. Follow State laws and regulations.
11. Follow State Laws and Regulations pertaining to firearms.
12. I agree to leave and remove my camping equipment/trailer no later than the departure date.
13. No unauthorized camping RV's, tents, or camping equipment allowed.
14. Unauthorized RV's will be towed at owners expense.
15. Stalling requires staying on grounds with animals. There is no overnight security.
16. Stalls must be bedded. Bedding is furnished by renter.
17. Stalls must be cleaned after use. Stalls not cleaned will be cleaned by Fairgrounds staff at the rate of \$60 per man and \$60 per machine hour and billed to renter.

Failure to abide by the above listed rules will result in immediate removal from the Fairgrounds.

**WALLA WALLA COUNTY FAIRGROUNDS RELEASE AND WAIVER OF LIABILITY AGREEMENT**

I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED AND AGREE TO ASSUME ANY AND ALL RISKS OF BODILY INJURY, DEATH OR PROPERTY DAMAGE, WHETHER THOSE RISKS ARE KNOWN OR UNKNOWN. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND WALLA WALLA COUNTY, AND SIGN IT OF MY OWN FREE WILL.
