### 1. Background/Introduction

Walla Walla Fair & Frontier Days (WWFFD) is an event facility located at the Walla Walla Fairgrounds in Walla Walla, Washington. The Walla Walla Fair & Frontier Days has been entertaining and educating the area community with an annual Fair since 1866 and numerous other annual events. Additionally, the Walla Walla Fairgrounds facility is the ideal setting for reunions, picnics, company parties, wedding receptions, banquets, indoor or outdoor activities, rodeos, horse shows, barrel races and other arena events.

#### 2. Project Goals and Scope of Services

Walla Walla Fair & Frontier Days is seeking an independent contractor to provide parking services for Garrison Parking Lot during the annual Fair, Sept. 1-5, 2021, from 6AM to 11PM Wednesday and Thursday and 6AM to 12AM Friday through Sunday.

The Contractor will provide adult personnel for selling parking tickets, directing cars, and maintaining lot cleanliness per contract. Personnel under 18 years of age may be used to direct cars with adult supervision. The Contractor must follow all County and City rules regarding safety, dress code and fire codes.
