16th Annual Warren County Corn Growers Tractor Ride

Tuesday, July 27th 2021, in conjunction with the Warren County Fair.

The ride will leave the fairgrounds at 8 AM with three stops along the way including lunch; returning to the fairgrounds late afternoon.

Tractor ride route: East from the fairgrounds on Hwy 92, South on S-23 to Milo for the first stop at the city park. Continue South on S-23 to Lacuna, head East on G-76 to Main Street, Melcher Dallas for the lunch stop at St John's Lutheran Church. After lunch head West on G-76 to Hwy 65. Then North on HWY 65 to Liberty Center for the 3rd stop at the SEW High School, then North on Hwy 65 to Lake Aquabi then North on 118th St to Nevada St., then West on Nevada ST to R-63, North on R-63 to Highway 92 then east on HWY 92 to the fairgrounds (63.7 miles).

Entry fee of \$30 for all Iowa Corn Grower members and \$35 for all other riders is due by July 23th which includes a hat and lunch. If you plan to have a ride-along, the fee will be \$10/person for food. We will be issuing all paid participants an ID bracelet which will be required for all food. Must stay on route, tractor should be 1985 or older. In consideration of your acceptance of this entry, I hereby, for myself, my heirs, my executors and administrators, waive any and all rights and claims for damage I may have against Warren County Corn Growers or any individuals associated with this event, its agencies, representatives, membership, successors, and assigns, for any and all injuries sustained by me in said event. I understand I am responsible for any and all damages to my equipment/tractor while at the fairgrounds or on the tractor ride. I attest and verify that I have full knowledge of the risks involved with this event and am physically able and sufficiently trained to participate in this event. I understand that the Warren County Corn Growers reserve the right to limit the number of tractors in the ride in order to control traffic and other administrative tasks. I give my permission for the free use of my name and picture in association with this event. I understand breaking these rules will result in the denial of all future applications and violators will be asked to leave.
