The Parties named above agree that "Horse Owner" (hereafter "Owner") desires WCEC Stable to provide boarding services below, and that WCEC agrees to do so under the terms described below.

1. Boarding services shall be provided at WCEC Stable's address above on a **Month to Month Basis from November 15th, thru March 31st**, and must have a valid open ride pass. Services may be terminated by either party with (1) one week written notice to the other party.
2. In consideration of boarding services, Owner shall pay WCEC the sum of **\$5.00 per stall per day**. Cleaning deposit of \$100 in a personal check is required (Check will be cashed if stall is not cleaned to WCEC standards.) **Stalls will be billed on a monthly basis unless arrangements have been made by owner. Owner will be billed on the 15th of each month.**
3. Owner shall provide to WCEC proof of the horse(s) up-to-date vaccinations upon request.
4. Owner hereby acknowledges and agrees that WCEC shall not be liable for any sickness, death, theft, injury, or other damage suffered by Owner's horse(s) during the horse(s) boarding at WCEC.
5. Owner hereby agrees to indemnify and hold Wasatch County Parks & Rec harmless against any claim for damages which may arise from any actions Owner's horse(s), including transmission of disease to any other human being or animal.
6. If the horse(s) require emergency medical care, WCEC agrees to attempt to contact Owner at the following telephone number(s): _____ before obtaining such care. However, if WCEC is unable to contact Owner within a reasonable period of time, dependent upon the nature of the emergency, then WCEC shall be authorized to obtain whatever emergency medical services it deems to be in the horse(s) best interest. Owner shall be liable for the cost of all such emergency medical services.
7. **Owner agrees to vacate stall(s) on dates that the facility has a scheduled event that requires stalling area. (Owner may have as little as (2) days' notice).**
8. Owner agrees to provide feed and watering buckets for each stall rented. Owner also agrees to feed and water horse(s) on a daily basis. **Grain/supplements and small pellet feeds must be in feed tubs or buckets to prevent stall grid heaving.** Resetting or replacement will be charged to owner.
9. Owner agrees to keep stall(s) cleaned on a daily basis and must use approved shavings that can be purchased from WCEC for \$12.00 per bag. Order forms will be provided and placed at stalls weekly. Ordered shavings will be invoiced each month. Owner also agrees to keep area around stall(s) clean and free of clutter, i.e.; feed, buckets, hoses etc. Facility will provide two stalls per animal to be rotated bi-weekly to assure stall to dry and keep smells to a minimum.
