RULES AND REGULATIONS

1. Spaces will be assigned on a first received basis, NO EXCEPTION! If you wish to be assigned a particular space, you must fill out the space reservation form and return it to the Fair Office along with your application and entry fee. The cook-off area layout is subject to change.
2. Early applications are due in the fair office by September 11, 2024 (\$160.00); late entries will be accepted until 8:00 p.m. on Friday, September 15, 2023. **All entries after September 11, 2024, must be paid by cash only (\$185.00).**
3. Spaces will be approximately 40 x 30 or 40 x 40 depending on location. Access to electricity and running water is limited and not guaranteed. Plan to provide your own shade. Only tarps or freestanding tents may be used. No tent stakes or any device that may damage the parking area will be allowed.
4. There will be limited vehicle access! **There will be ABSOLUTELY no vehicles parked in the cook-off area or in cook-off spaces. No vehicles will be allowed in the cook-off area after 6:30 p.m. on Friday and not at all on Saturday. Vehicles must be parked outside the cook-off area.**
5. **Chef's Choice** entries must be cooked from scratch, on the grounds, on a bar-be-cue pit.
6. Each contestant may cook two separate pieces of the type of meat it submits as its entry (e.g., two slabs of ribs, two chickens or two briskets). All meat can be cooked with sauce but may not be turned in with any sauce.
7. There may be two head cooks per pit; each head cook MUST have their own meat for turn-in. **If multiple entries are turned in from the same meat, it will be grounds for disqualification.** A BBQ pit may include gas or electricity **ONLY** to start the combustion of wood. Contestants' pits may be inspected for conformity. All fires must be of wood or wood substance. All fires must be in containers, not on the ground. Holes, dug pits, or open flames in boxes or other container resting on or less than two feet above the parking lot surface are not permitted. Open flames of any kind are NOT permitted (e.g., tiki torches or campfires.) All pits must be diapered to prevent coal or grease damage to the parking lot surface.
8. Contestants will NOT be allowed to sell any barbecue. Barbecue contestants may give barbecue to spectators, if they wish.
9. No keg beer allowed on grounds - can beer only. No cooler or cases of beer may be brought into cooking area after 8:00 pm on Friday. The Beer bar will open and available for purchase on the grounds. Excessive use of alcoholic beverages will be grounds for disqualification. Please observe state liquor laws. **The serving of alcoholic beverages to minors is strictly prohibited and will result in disqualification.**
10. Sound amplification should be used in moderation during entire cook-off and must be turned off from midnight Friday until 8:00 a.m. Saturday. This rule will be strictly enforced and refusal to abide will result in immediate disqualification and eviction from the grounds.
11. No skateboards, tricycles, bicycles, motorcycles, mopeds, three/four- wheelers, UTVs, or golf carts will be permitted inside the cook-off area **by Teams, Their Guests, or Spectators.** Absolutely no pets allowed.
12. It is suggested that you bring suitable shelter as the weather may require. RAIN OR SHINE - the contest will go on.
13. Each team will be responsible for clean up of their space. Hot coals and ashes should be disposed of in containers provided for them (not on the ground or in regular trash cans). The chief cook will be responsible for the conduct of his/her team.

14. All contestants and equipment must be off the fair grounds by Noon on Sunday, September 15th.
15. The WCF BBQ Committee reserves the right to make additional regulations as situations warrant. **Decisions of the committee and CBA judge coordinator will be final.**
16. The Washington County Fair Association, committee members, and sponsors will not be liable for theft, damages, or any accidents.
17. WCF, King of Coals is a Champions Barbecue Alliance sanctioned event. The CBA rules for the sanctioned events are to be followed by all contestants & will be enforced by the WCF Committee & the CBA Judge coordinator.
