1. PUBLIC WELCOME by Chairman Thomas

2. CONSENT AGENDA

Wade commented on the following:

- (a) Finances are about where we would expect for this time of the year. Expenditures and income are about on line. Wade noted we received our last Hotel/Motel tax for an approximate amount of \$123,000, all money received to date is within in line of the total projections for this line item.
- (b) Wade directed Board to review Page 3, line item 10. This line item breakdowns the income received per buildings. The correlating expenditures are depicted on page 5, line item 113 B. If no activity in a certain building, then no number is designated to those line items. Wade indicated this will serve as a good management tool. Fair board members entertained questions with Wade regarding some of the income, and expenditures.

SPIESSCHART MOTIONED TO ACCEPT THE CONSENT AGENDA AS PRESENTED. LEAHY SECONDED THE MOTION. MOTION CARRIED UNANIMOUSLY.

3. RODEO BOARD

Fred Boyles indicated that Wade had called him Friday and wanted him to get a hold of someone to do the beer just for the Rodeo. Boyles indicated late Friday and Monday morning he called Donna Keppler with Coors who lives in Colorado. She call Boyles last night just as he had walked in the door. She indicated they are not interested in bidding just the beer for Rodeo, they also want the Fair. This brought Boyles to another question, (issue), he distinctly remembers in the October

meeting minutes that a motion was made by Dave Lintz and seconded by George Otten. This motion indicated that we call for bids on beer and that they be subsequently opened at a Fair Board meeting on the 5th of March or March. In the October minutes, (refers to original minutes), Boyles makes a point that this motion was not made in the minutes.

Wade indicated he had a discussion on this at the last Fair Board Meeting (not sure exactly which meeting) and Wade explained this was normally done by negotiation process for beer sponsors because of the dollars that are involved. Wade continued to comment that if we go out with sealed bids we are not going to get the response we're looking for. Wade further indicated, that when he called Boyles the other day he had told him he (Wade) had talked to these other (2) two people and had indicated to Boyles that Wade had talked to Mt. Hood. Mt. Hood suggested that the fair try to get Coors to come in and bid for the Rodeo. This was thought was suggested with the idea that it may bring more money altogether. Wade further indicated the fair needed a \$12-\$15K sponsorship. This number ranges a little every year depending on what Mt. Hood does for us. Mt Hood suggested we talk to Coors because they said they were confident Henry's would go along with it. Lintz indicated it was his expectation when we had that motion that while the word "bid" may be incorrect, that Wade was going to go and ask those through the distributors, probably, but ask those specific brands to provide sponsorships. That we would solicit them for sponsorship. Wade commented that that is exactly what he did. Wade further noted he had come back to with a solution before we ran around and jumped the gun here, it was suggested that we try to see if we could get a joint thing going with Henry's and Coors. Wade again indicated that was the reason he called Boyles. Wade clarified again he had called Boyles to give him some help so that we could write up a proposal to Coors to say just exactly what we're going to be doing for them, i.e. advertising etc. in the arena.

Lintz inquired why wouldn't we ask each of those brands to provide a sponsorship for the entire fair.

Wade commented we can do that. That's what I was saying. Wade felt we might get more money if we went the other route and that is why he had called Boyles asking for some help on it.

Boyles thought it was supposed to be a sealed bid.

Wade responded by saying no, that this type of item one would negotiate.

Boyles felt the proposal and that the motion Dave Lintz made was that we were going to ask for sealed bids. Boyles asked confirmation from Lintz.

Lintz indicated that was his recollection. Boyles confirmed.

Wade commented to Lintz that he had talked to him about that and it was...

Lintz commented the discussion was subsequent to the motion.

Lintz indicated to Wade that we may be able to negotiate with an individual that provides the services of the proposal. we probably have an issue with how to do this with the county.

Wade indicated that we didn't have an issue with the County. Wade felt there was an issue from the standpoint of trying to negotiate out the best deal. From experience, it has been better in large amounts like this to go out and negotiate. You do go out for bid with soda pop people.

Thomas takes time to introduce Alan Rappleyea.

Rappleyea comments that whatever the board want to do and that we have the flexibility on this. We can have either a sealed bid process or we can have a negotiated process where it provides a flat service and get some money from the process. Whatever avenue we decide to pursue we will need the blessing of the board.

Thomas questions if it is the blessing of the fair board and/or the county commissioners.

Rappleyea commented that both the fair board and the county commissioners. Inquiry was made from the audience why we couldn't ask for a sealed bid with a minimum.

Wade responded that we can put the thing together anyway we want.

Comment made from the audience this way we were not under, but rather over if anything.

Wade commented the whole reason were going the other way was because he felt we'd get more money out of the deal as did the distributor. This idea come from the distributor, not Wade.

Otten had some question about who the distributor was.

Wade responded that it was Mt. Hood.

Williams commented that we needed to get back on track. What the question was is that the minutes are not correct. All the policy made at the October meeting were in full sprint. A motion was made and it was accepted. A motion was made about the beer and it was accepted at that meeting in October. But that particular motion and second was not formulated in the minutes as a motion. So those minutes were not correct.

Garza inquired as what minutes he was referring to.

Thomas commented the October minutes.

Garza inquired as to why this issue was not raised at the November meeting. Williams indicated he did not know why they weren't. But again stated that they are not correct.

Garza inquired of Williams if he wanted to make a motion to amend the minutes. Williams commented he is a not a board member.

Garza inquired the wish of the board.

Williams again stated that all he was saying is that the board should note that those minutes are not correct.

Garza commented to Speisschart that the office has the tapes of that meeting. Lintz asked for minutes to be reviewed.

Boyles further commented that Donna Keppler is waiting for sealed bid documents. Rappleyea commented he had talked to the Fair Board that this is not a typical bid process. Usually you see the bid process in Oregon Law where you are going to be purchasing a roof, or a fleet of vehicles, or a concrete sidewalk. This is a little bit different where we are going to be earning money from this thing. The fair can still apply the same principles to that process to maximize the public profit out of the operation. You can still do the competitive process and where possible indicate that you will receive "X" number of dollars for the privilege of serving the beer.

Lintz indicated that was exactly what the fair board was expecting.

Rappleyea indicated that was the same conversation that had been held in the past (in October).

Lintz indicated those beer manufacturers were looking for something that was all discussed and shown to the board at the same time.

Rappleyea indicated he thought there has to some care to draft this so that everybody who gets the bid on this or submit their proposal has the whole understanding and facts. That they compare apples to apples and not apples to oranges.

Lintz agreed with Rappleyea.

Thomas finishes introduction of Rappleyea to the audience. Rappleyea is the Assistant County Counsel. County Counsel is Dan Oleson. Mr. Rappleyea is here to help the Board out on issues such as the one being discussed.

Boyles gives Rappleyea a sample of the bid request presented at the October meeting.

Lintz commented that he had asked at that meeting that the staff work with you to create the language. Lintz reiterated he would like this to be done. That the language goes out to those beer suppliers have the review to make sure what you have just said is correct. They all have the same quantity of beer and related items noted.

Leahy inquired if we had some kind of deadline to be concerned with.

Thomas inquired from Wade as to how much time we have for this.

Wade indicated we needed to move on it. Wade further commented he had talked to all the vendors, all the distributors.

Rappleyea indicated this process could be as formal as the board wants it to be or as informal as the board wants it to be, as long as the board gets permission

from the Board of County Commissioners to do it that way. Rappleyea further commented that his office has been in discussions with Wade and McKinley about trying to get some permission form the Board of County Commissioners s to what type of process we choose for the beer contract, carnival contract and other types of related contracts, however the board decides.

Lintz inquired if the county commissioners could act on this at their next meeting. Rappleyea commented that they would need more time than that.

Wade commented probably about two working weeks.

Thomas inquired what the board could do to help this along.

Wade commented that we needed to get busy and do it.

Lintz commented that all we needed to do was prepare the package that we wanted to send out.

Rappleyea indicated yes.

Lintz further added it would need to be given to the county commissioners and ask their permission to do this.

Rappleyea commented by saying yes. He noted that an explanation of how this deserves to be profit for the county, why this is a good for the county, how this is fair to the all the vendors, too. Noting that this allows all vendors to be on an equal footing and the county is maximizing profits for the county.

Wade further asked if the board wanted to put a minimum bid or offer amount.

Lintz inquired what the current sponsorship was at.

Wade indicated it would range between \$12-15K depending on the year. Depends on things like in-kind money.

Lintz inquired about the minimum cash contribution amount.

Wade indicated he was not asking for the amount. Wade knows how to determine the amount. Wade inquired if the board wanted an amount put in the bid/offer.

Wade further commented the minimum could be "x" dollars.

Lintz indicate he thought the fair board should include a minimum amount.

Wade indicated he would use the minimum used from past years.

Other comments were made by Speisschart, Lintz, Leahy, Rappleyea, Wade, Boyles relating to this topic.

LINTZ MADE A MOTION THAT THE FAIR BOARD PROVIDE ENOUGH DATA TO MAKE THEIR SPONSORSHIP BID ACCURATE. THAT THE IT GO TO A MINIMUM OF (5) BEER VENDORS, LOCAL DISTRIBUTORS. 4. BOOSTERS

Russell indicated they were in the process of completing their organizational changes. The have completed the changes in the constitutional bylaws for their group. Boosters will be on target with most of their projects.

Mentioned they have gotten a lot of new members. They have a new board member who is also a Rodeo Board member, Mr. Jack Price.

5. 4-H HORSE FAIR

Newman gave the following report:

- (a) Concerned about when the fair books are coming out since the registration date is June 1st. McKinley indicated he would comment on this in his report.
- (b) Bill Peterson wanted to thank Wade for the letter which cited the \$7000.00 allocation for the stalls.

Johnson commented that things were progressing much like last year. They expect to have about 230 participants.

Margret McVey had three things to comment on:

Building of the stalls. She inquired what they 4-Horse advisory need to do to have the Fair Complex office advance them \$2000.00 to build (2)two model stalls. She indicated that they have no money. Models need to be built in order to write grant material requests to potential sponsors. Wade agreed to advance the money. Wade further commented that \$2000 had been collected many years ago and \$5000 was approved at the last fair board meeting for the improvement of the Horse facility, for a total of \$7000. Wade commented it would take \$10,000 in section of 29. Wade suggested to the board to go ahead and build the first set; and then it would be up to them to build the next one; and us the next one; and work a deal like that. The problem Wade cited was that we waited so long that he really questions if we would be able to do this in the dates that was spoken of. Probably more realistic would be after fair in the fall.

McVey defers to Hoeflich. Hoeflich comments they want to see what they (sponsors) are buying. Therefore the need to build two models.

Wade confirms that they are not talking about building a set of 30 or so. Hoeflich states no, they just want to build two models.

Wade defers to Bemis, Newman and Johnson to build the first two in a prototype fashion. They are to look at the design, etc. Wade confirms money was allocated to 4-H for \$7,000.

Lintz confirmed that \$7,000 had been allocated in the budget for this use, so the board can certainly release the \$2000 for the purpose of building the prototypes. They would use their labor and the money would be spent on materials.

Otten inquired if this money was in this year's budget or next year's. Wade confirmed that it was in this year's budget.

Speisschart commented we should the bills submitted to the Fair complex office and the office pay the bills.

McVey again makes mention that they don't have money.

Wade commented the horse people should come in and the fair office will work the payment out.

(2) Contracts for Judges. McVey indicates the horse people have always supplemented \$25.00 per day to the fair office amount of \$75.00. They have done this because horse judges require \$100 or \$125. Wade suggested to the Fair Board that this be handled by the staff to take care of this. McVey further commented she wanted to see the contracts because last year judges didn't get paid.

She had many inquiries about payments.

Speisschart commented that maybe McKinley should copy a copy of these horse contracts for Margaret's review. If a transmittal is available, that Margret get that as well.

Lintz confirmed with Speisschart.

(3) 4-H horse people concerned with the way they have been treated in the past. McVey commented that at the last meeting a comment was made that the 4-H horse people are 100 % satisfied and that this is not correct. She indicate they go through monthly meetings where parents are very angry because they have to pay \$65.00 per child to go to Fair to have a stall. Parents are ready to go to another fair. They are angry. Wade gave historical perspective on stalls. Proposal was given to the fair by the horse people not fair to horse. The horse stalls are to be rented, horse groups to rent out. If Fair uses stalls, then fair pays for those days stalls are used, as would Rodeo. Wade comments this idea came from Horse Advisory committee. Margret say not the committee. She indicated she knew nothing about this plan, until the stalls were removed.

Lintz inquires about the number of stalls needed.

McVey indicate 100 box stalls.

Discussion was held on tie stalls.

Williams commented that Sue Oxendine and 4-H Advisory negotiated rentals for the stalls. Everybody who uses the stalls pays for the stalls used.

McVey further disagrees with Williams, indicated this was not the way it was presented to her.

Gray gave input on stalls. Stalls were torn out because they were a mess. They were rotten. 4-H leaders decided the tie stalls were not safe. Stalls were removed after the Fair Board and sue decided they were unsafe. Box stalls then became an option. We would rent them to all potential users.

Thomas directed that a committee be formed to head this issue of the stalls. Committee to be made up of: Speisschart representing the board, Bill Peterson representing the Horse folks, Bill McKinley for fair, Bemis for the fabrication and Ron Egberg representing the superintendents.

McVey felt okay with the committee idea.

LINTZ MADE A MOTION THAT THIS COMMITTEE IS TO STUDY THIS ISSUE AND COME BACK TO THE BOARD AT THE NEXT BOARD MEETING WITH SOME KIND OF PLAN. MOTION WAS SECONDED BY OTTEN. MOTION CARRIED UNANIMOUSLY.

6. 1997 FAIR REPORT

Bill McKinley, Fair Coordinator, reported on the following:

- (a) Premium Books. We currently have a temporary worker working on the revisions for the premium books. Book is to be out by early April. This is 2-3 weeks earlier than last year. Fair representatives have also been incorporating state requirements into the premium books.
- (b) Judges Contracts. Most of the Judge's contracts are out. McKinley has had two (2) meetings with various superintendents to make sure contracts were out to the respective Judges. Lintz again suggested to McKinley that copies of the list and contracts be sent to Margret McVey. McKinley noted he would take care of it.
- (c) Concession revenue is continuing to come in.
- (d) Ordering tickets, credentials, arranging for ambulance
- (e) Commented on Paige Payne, a temporary employee handling the second stage and walk around entertainment. She is also helping McKinley organize Fair related items. She is a tremendous help and team player.

- (h) Also working on many other detailed issues that come up on a daily basis.

Garza, Marketing Representative, mentioned the following:

- (1) Referred Fair Board to pages 24 25 in their packets for the March, 97 activities. Cited that DJ's Motorcycle Swap was here now mobilizing for the weekend event. Gem & Mineral Show is scheduled for the middle part of March. March continues to be a good month for the Fair Complex in that we have weekends available to rent facilities. Good month from a revenue standpoint.
- (2) Other activities not so readily visible by the handouts are the following: (a) in the Cloverleaf we have 3 receptions, 1 Unified Sewerage Dept meeting, 1 Dept of Corrections public hearing and 4 bingo nights; (b) in the Floral, the Civil Air Patrol continues to rent every Monday night; (c) in the Arts & Crafts we have 3 evenings of dog training of which most of them are private vs. 4-h; (d) in the Main Exhibit, we also have 3 nights of dog training; (e) in the Armory we have scheduled 1 public dance, 1 religious organizational meeting, and one private birthday function.
- (3) Garza continued to state that January was slow, February the activities picked up and now in March the complex is much busier. Garza expects April-October, 97 to very busy. Additionally she added that she typically receives about 30-40 calls a day.

8. MAINTENANCE REPORT

Albert Flanagan, Jr., Maintenance Team Member gave the following report:

- (a) Wold has been very busy working on the drains, the grounds and other related fair complex duties.
- (b) Bemis has been cleaning and fabricating, repairing and maintaining buildings, as well as helping with the event set up and tear down when necessary.
- (c) Jordan continues to work hard at the mechanical work and electrical work of the fair complex. He has also helped with the set up and tear down of events.

(d) Flanagan, Jr. has very busy setting up events for the month of February, 97. He has also been helping the rest of the maintenance team on other projects as deemed necessary.

9. OLD BUSINESS

(a) Report on Progress of Audit.

Wade commented he had met with Personnel, Purchasing, and Finance. McKinley and Garza accompanied Wade to those meetings. Wade also mentioned he had meeting scheduled with Purcell to discuss items on the Audit. As noted, progress in well on its way. Wade suggested that a committee be organized to review and design the mandatory changes. This should be done within another month or so. Committee should consist of Fair Board members to go over and discuss changes and decide what makes sense and what is feasible and realistic. Once this is done, then this committee would present it to the entire Board.

(b) Minnick Law Suit.

This is the lawsuit that involves the woman that got kicked in the covered show rings by a horse. Our attorney feels the Fair Complex will prevail. The trial is set for August 26, 1997. It is a two day trial.

- (c) Reminder of the Larry Helms seminar entitled: Managing the Speed of Change. This seminar is to be held on March 17, 1997 at the Clark County Fairgrounds. Wade referred Fair Board members to page 29 for the letter regarding this event. Wade encourage Fair Board members, Rodeo members and staff to attend.
- (d) Appraisal of Dog Leg.

 Wade commented they wanted a legal description of the property. They apparently have done appraisal and putting the documents together. Lintz requested Rappleyea to follow up on the status of the appraisal.

10. NEW BUSINESS

(a) Ladder truck
Our ladder truck is non-certifiable. Jordan indicated to Wade that a \$5,000 fine could be imposed for using a non-certifiable ladder truck. Ladder truck would not pass OSHA and workmen comp agencies for safety

purposes. The fair complex purchased a bucket truck for \$6,000, they gave us a trade-in value of \$2,000 for our old truck; which left us with a net of \$4,000. Wade further indicated that the Board needed to declare the old ladder truck as surplus so that we could be legal with the property disposal. This truck was out of certification. Jordan did comment on the specifics of the bucket truck.




