MCGOUC THAT THE JAYCEES MAY USE THE ARENA TWO DAYS FOR THE MOTOR CYCLE EVENT AND FAIR EQUIPMENT AT THE RATE OF \$10 PER HOUR IF THE ARENA WAS LEFT IN THE SAME CONDITION AS IT WAS FOUND IN; AND PROVIDED ADEQUATE FIRE INSURA CAN BE PROVIDED. MOTION CARRIED.

Ray Kozak gave an updated report on the ad program. He showed the Board a minature reproduction of the Billboards which will appear in approximately 25 locations in the area. The boards will appear on July 16 and will receive an override of about one week for a total of three weeks. Theme of the fair is "Fun for the Family ... Naturally!. A premium book cover was presented to the Board with several colors. As the agreement with the Argus called for only one color, Addy Hesse was asked to check into the possibilities of cost to have the two-colored cover. Mr. Kozak will meet with Mr. Joss and Mrs. Hesse by April 17 to complete advertising ideas.

Mr. Springer has made arrangements for the Fair Board to appear at the June 1 noon meeting of the Beaverto: Chamber of Commerce to be held at North's Chuck Wago in Beaverton.

Mr. Jossy will check with Pacific Chain and Link and Zidell Machinery Company and ask for a bid with specifications. Ball said the Green Thumb will work 2 days the first two weeks of each month and 3 days the second two weeks of the month. The crew is presently working on the rodeo coral. Thirty pressure treated posts are being installed.
