OPERATIONS Director Hesse introduced new Operations Superintendent Ron McAuley who started in the new position on March 26. Fair Board welcomed McAuley to the "fair family."

FORCE

The Board reviewed a memo to Charles Cameron, Assistant County Administrator, stating the Board's intention to proceed on the master development plan by preparation of a comprehensive plan and zone change and appointment of a task force to assist in developing an economically and environmentally sound proposal for commercial development. Hesse has received no reply as yet. The Fair Board authorized Hesse to appoint the five-member task force after receiving suggestions from the Board of County Commissioners. Hesse will be communicating with the Commissioners through Bob Davis, Senior Analyst.

RODEO

Hesse, Sprecher, Love, and Rocky Williams, Rodeo Committee Chairman, met on March 27 to clarify the budgeting procedure and several points in the March 5 Rodeo Committee minutes. At the April 2 Rodeo Committee meeting Williams explained the rodeo portion of the budget to the group, and all seemed to understand.

BUDGET

The Board briefly discussed the fy 1984-85 budget. The Board agreed to concentrate their effort on passage of a hotel/motel tax increase and support of the upcoming county tax base.

ELECTRICAL REPORT

Oper. Supt. Ron McAuley is reviewing the electrical report submitted by Unified Sewerage Agency. Areas needing immediate attention are the horse barns, swine barn, milking parlor and Friendship Square. McAuley will update the Board at the May 2 meeting.

INSURANCE

The recent barn fire at Curry County Fairgrounds raised several questions about fairgrounds insurance covering facilities and livestock. Hesse will be meeting with the county's insurance company to clarify coverage.

McAuley purchased a 1977 Ford pickup truck for use on the fairgrounds. The fairgrounds logo will be painted on the truck. McAuley is compiling a list of surplus vehicles and equipment for the next county auction.

ADVERTISING Hesse has hired professional graphic artist Jim Mills to put together the art work for the fair posters, newspaper ads, and bus cards. The Fair Board reviewed a preliminary poster sketch and agreed it portrayed the fair as family, fun, and western. Hesse is concentrating on quality advertising this year. She will purchase 50 bus cards and 500 slick posters--cost is not included in graphic costs.

GOLD MEDALLION

JK

The Board noted the framed gold medallion from the County Fair Commission.

FFA

The Board Board received an invitation to the Hillsboro High School FFA Banquet which will be April 28.

4-H

The 4-H Home Economics have scheduled a mini-fair in the Cloverleaf Community Building on May 12. Two stoves, a refrigerator, and a mirrored demonstration table have been donated for the building. All 4-H home economics demonstrations will be held at the fair this year. Sprecher will attend the mini-fair and express appreciation from the Fair Board.

RACING

The Oregon Fairs Association lobbyist estimated that funds to be distributed through the Merit Rate program will be 40% less than 1983.

LELL RD. Construction on Cornell Road is scheduled to begin in May. Fairgrounds users will need patience in using the grounds this summer.

ORDINANCE 288

Sprecher reported that quite a few people attended the March 28 public hearing on Ordinance 288 adopting the fairgrounds master plan. The Fairgrounds Boosters actively pursued a change in Section 6 (sunset clause) of the ordinance.

Section 6 originally stated that "due to uncertainty of county finances, this ordinance shall be repealed effective March 1, 1989." A-engrossed reads ordinance to be "reviewed" effective March 1, 1989. After public testimony and Commissioner discussion, Section 6 B-engrossed reads "Due to uncertainty of county fairgrounds development finances, this ordinance shall be reviewed on or before April 1, 1989, and again on or before April 1, 1994. Section 2 item 5 "dedicated fund" was also clarified in B-engrossed.

Chairman Sprecher testified the Fair Board would like the ordinance to be reviewed rather repealed, but understood the Commissioners did not want the change and decided not to pursue the matter.

Ordinance 288 B-engrossed was passed by the Board of Commissioners on April 3. Myllenbeck acknowledged a thank you letter from the Fair Board.

Baron mentioned the RUDAT study and the fact that downtown store owners would like commercial development downtown rather than at the fairgrounds. There is community support for both sides. Baron will keep the Board informed of downtown discussion.

BOOSTERS

The Boosters met March 7 and agreed to paint the concession stand. They are soliciting new members and updating the bylaws. Sprecher reported the Fair

Board's position on Ordinance 288 and again thanked the Boosters for donating the Cloverleaf Community Building heating system. Hesse will attend Booster meeting tonight.

EVENTS

Leeson brought Donna Hodge, Administrative Assistant, Tualatin Hills Park and Recreation District, to see fairgrounds facilities. Hodge will be referring events to the fairgrounds that the Jenkins Estate cannot accommodate. The Cloverleaf Community Building does need graveled parking and lighting.

HOTEL/ MOTEL Hesse will be meeting with county motel owners/managers on April 5 to discuss unmet county convention needs and a hotel/motel tax increase. Rumor has reached the fairgrounds that plans are being approved for a motel in Hillsboro near Intel. The City Planning Dept. told Hesse someone had recently inquired about the city ordinance on hotel signing.

RODEO

Rodeo Committee Chairman Rocky Williams reported that Jim Russo will be resigning from the Committee because of family illness. Fair Board will thank Mr. Russo for his contribution.

The Committee now has an understanding of the budget and is pleased with it. The Committee received a donation of materials to build a VIP booth and will be starting construction this weekend.

Fair & Rodeo Court attended and was introduced to the Fair Board. Queen Kathie Brooks, Princesses Shirley VanDyke and Casey Westlake. Judy Brooks is the Court's chaperon. The Court reviewed their upcoming activities and displayed their equipment. Andrea Books forfeited her princess title and alternate Casey Westlake assumed princess duties. New alternate is Sheila Whitehead. The Board recessed so Leeson could photograph the Court for the 1984 premium book. Fair Board was invited to attend the Coronation dance to be held in the Cloverleaf Community Building April 21.

DERBY

Gary Backstrom, Derby Committee Co-Chairman, and Joel Lewellen, past chairman, updated the Board on derby drivers association activities. The association wants part of profit, more derbies and more control of technical check in. Lewellen attended the last association meeting and relayed the Fair Board's position. The Fair Board welcomes all safety and rule suggestions and help in technical check in. The Board will not consider distribution of funds to the association, and the Derby Committee is not interested in running more than three derbies in a year. The Derby Committee has the final decision in rule changes and interpretation. The derbies are put on by the Fair Board to raise money for the fairgrounds and will stay that way.

The Hillsboro Chamber of Commerce will be having a fourth derby and should have plenty of people to help the derby committee. The Chamber is responsible for their own technical committee, security, ambulance, and liability insurance, etc.

Hesse is working on getting a donation of bigger logs for the arena. Insurance rates have jumped from \$250 to \$500 per event in 1984.

The driver association representative did not come to the meeting. Hesse will reconvey the Fair Board's position to the association. Backstrom will review the rules and forward changes to the office. The Board thanks Mr. Backstrom and Mr. Lewellen for attending the meeting.
