4-H WORK DAY

Ms. Simpson visited with the Fair Board about having a work day in the near future. Fair Board will provide a list of tasks and provide the material for same. Tentative date has been set for July 9.

Mallory questioned the Fair charging 4-H for use of fairgrounds facilities. Reasons are cost of power for large buildings, and turning away paying users who are also part of the community. Concessions currently being made in favor of the 4-H program include free gate admission to the fair for leaders and students, 1/2 price season passes for 4-H parents, and rental of the armory for Home-economics exhibits during the fair. In addition, most outdoor functions are allowed free as power bill is not incurred. All money made from the Chuckwagon is kept by the 4-H Leaders Assn. and the Fair Board spend over \$7,000 on premiums, ribbons, materials, judges, etc. If the Fair could receive more monies from the County perhaps the Fair could allow usage at no charge. In 1976-77 budget the Fair received \$3,000 from the County. Fair Board cannot maintain all 22 buildings and 83 acres without revenue. Evers made mention of the rotting Main Exhibit Building roof, with estimated repair cost at \$30,000. The Fair Board is also heating the 4-H building at a cost of \$40 to \$70 per month. The Board is concerned if events continue as in the past, there will be no facilities for anyone to use.

Both Groups expressed concern on getting along and doing the best job for the greatest advantage for all.

NATIONAL SADDLE CLUB ASSOCIATION REQUEST Oregon Horsemen's Association representatives asked the Fair Board to negotiate a contract for usage of the fairgrounds facilities for a National Saddle Club Association - O-MOK-SEE Show for August of 1978. Discussion included required facilities and possible cost of the proposed five day event. Douglas County Fair Board has also been asked for a proposal.

Written proposal will be furnished to the OHA by the end of April.

GROUPS

MEETINGS WITH HORSE Jossy met with the Associated Riding Clubs of Washington County and reported he had received a fine reception and that all Groups were sent Expo letters. Boyer reported meeting with 4-H Advisory Group and said the communication had been excellent. Both Groups were asked to present constructive ideas to the Fair Board on how money should be spent.

PABBIT-POULTRY BUILDING

Blue prints are in hand and several bids have been received. Several more builders will be contacted.

MILK PARLOR

Evers reported that the State milk inspector has approved proposed milk parlor sketch subject to changes.
