MOTOCROSS

Bill Amick presented a financial statement for the operation of motocross racing. The statement included projected attendance, expenses and revenue based on information obtained from the McMinnville track. Amick felt several trial races should be held to gather information on community feelings, and he is ready to begin as soon as approval is given.

Holland asked who would be responsible for the physical preparation: bleachers removed, gate moved on north end and track prepared. The requirements for motocross usage is mostly labor. Amick will take the responsibility.

Fair Board and Amick would like to meet with the City Manager, Eldon Mills, to discuss the possible motocross track at the fair-grounds.

Hesse will try to arrange a meeting with the City August 22-28.

Amick added that the approximate race time could be Sundays, noon to 6:00 p.m. He will also gather information from the Portland International Raceway and McMinnville for presentation to the City.

The bills were printed and submitted for approval.

SOIL DRAINAGE

To be updated on the soil drainage project, one need only to look outside. John Leffel, gravel acquisition leader, did a fine job on Saturday, August 18. Trucks worked from 6:00 a.m. and finished around noon. 50 trucks and 15 trailer loads of gravel were hauled from the gravel yard and stockpiled on the fairgrounds.

All toll, 740 yards of gravel were delivered and 430 gallons of fuel were used on Saturday.

SOIL DRAINAGE continued

Three backhoes, two laser trenchers and several blades arrived Monday moring to begin the project. The project using heavy equipment will continue through the week. 70 downspouts will have to be dug.

No words are adequate for the sincere gratitude extended to all who have denated to this project.

Boyer will donate the plates, napkins and silverware.

FAIR EVALUATION The 1979 County Fair was the best ever.

Boyer was pleased to have all the Board members so willing to help throughout the five days. Each day brought new events to be handle but each day was relaxed with no pressure not expected.

Colegrove felt the Board members should not get totally involved in any one aspect of the Fair. But because of the need, time spent was important. The Horse Show had some problems this year that wil be addressed at a later meeting.

The Fair Board feels the Rodeo needs to be reevaluated.

POLICE EFFICIENT Boyer reflected that the Hillsboro Police Department did an admirable job on the fairgrounds during the Fair. The Fair Board can't thank them enough and looks forward to working with them again.

HOLIDAY MARKET The Holiday Market will be held November 23 and 24, Friday and Saturday.

Fees for a booth at the Holiday Showcase will be \$40.00 for commercial non-food booth (8'x8') and \$75.00 for a food booth.

FINANCIAL RECAP The financial recap for June was submitted to the Fair Board.

The Oregon State Rally Squad was allowed to run the concessions in the grandstand area during the Rodeo and Draft Horse Show during Fair. The girls sent a thank you to the Fair Board. They earned enough to permit them travel to the Oregon State Football game in New Mexico. (They received no travel expenses from the college.)

Hesse wrote a thank you note to Robert MacVicar, President of OSU, for his permission for the Rally Squad to participate and call his attention to the quality of the goodwill ambassadors representing OSU.

JoAnn Burton, Open Class Poultry Superintendent, has submitted her resignation. She has been with the Fair for 14 years and has done an outstanding job. An appreciation certificate has been made and will be signed by the Board members and Director.
