## A Special Meeting of Fair Board Held August 24, 1977

CALL TO ORDER AND ATTENDANCE

HAUNTED CAVES CONTRACT

It was reported by Mrs. Hesse that she has negotiated a contract with Harley Crowder of the Active 20/30 Club for the Haunted Caves Event October 21 - November 2. In addition to rent, the 20/30 Club will pay for power used during that period

SOCCER LEASE

Ed Wolfe attended the meeting to discuss the leasing of the property on the northeast corner for use by the Hillsboro Soccer Club. He reported there are several soccer fields in surrounding communities but facilities are very limited in Hillsboro for both youth and adult. Hillsboro Soccer Club consists of 35 teams. The Fair Board reminded Mr. Wolfe that all Washington County residents will be paying for the field and it will not be accessible to all residents.

It was decided that a chain be constructed across the diagonal road inside fairgrounds entrance so as to dissuade any vehicle traffic on the field. In the event of the fairgrounds needing extra parking, the fair event will have precedence over use of the field for parking. Mr. Wolfe was told to submit a schedule of events as soon as possible.

REZONING FAIRGROUNDS Mrs. Hesse will meet with the City of Hillsboro and County Counsel August 25 at 10:00 a.m. to begin procedures for rezoning the fairgrounds.

1977 FAIR REPORT

A report was given by Mrs. Hesse that the 1977 Washington County Fair was a success. Off-season usage was up \$3,600.00 which was double 1976 figures. Fair attendance was up 5,750. Paid premiums were down in 4-H but remained the same for open class. The increased revenue was attributed to the success of the rodeo and destruction derby. The 1978 Fair 53 will have the theme of "Sunshine Days" and Mrs. Hesse will begin meeting with the department heads soon (August 25) to evaluate the 1977 fair and commence planning the 1978 fair.
