During the audit, the matter of the bill KWAY owes from 1961 was called to the attention of the secretary. This secretary had called and written concerning this bill and had been informed that the station had changed hands several times since 1961. Mr. Simantel made a motion to write off this amount.

Mr. Danielson secondeda Motion carred.

The secretary had called several of the Chamber of Commerces in the county to see if they would be willing to help create interest in the fair. The only Chamber that was interested was the Forest Grove Chamber. They would like to have the Gleeman sing and have talent from that area on Friday night. The cost to have the Gleeman would be \$200.00. After some discussion, the board agreed to have the Gleeman sing. The thought of having them at the grandstand was discussed. Mr. Ball will see what would have to be done to get this area ready.

The winner of the Theme contest held during the fair last year had called the secr tary and informed her that she had never received the prize. The secretary had talked to Mr. Roberts and he stated the Whale Cove Inn had gone bankrupt in January and that Mrs. Wallender had called him in February about the week-end. He felt there was nothing that could be done. Mrs. Wallender said she had never heard from Mr. Roberts and he had never sent her the letter of introduction for the week-end. After some discussion, the secretary was asked to talk to Mr. Roberts about this and if

nothing could be accomplished, the board would give Miss Wallender \$25.00 for a week-end at the beach. Mr. Simantel made a motion to this effect. Mr. Danielson seconded. Motion carried.
