The Washington County Fair Board met at 8:00 p.m. at the Fair Grounds with all members present.

Representatives of Cedar Hills Garden Club were present for the purpose of determining location of drinking fountains which they wished to donate and install on the grounds.

The minutes of the last meeting were read and approved.

Mr. Abts reported that he had taken up the insurance on the buildings with the County Court and that they agreed to place the insurance under the 90% agreement with the county.

Motion was made by Nyberg and seconded by Abts that we pay \$100.00 to the County Extension Agents Office for clerical help in 4-H work. Motion carried.

Mrs. VanLoo of the Extension service was present asking for the Danish System in judging on Home Economics of the 4-H work. A suggestion was made that the 4-H Leaders Association be contacted by the Agents office and that their opinion would be abided by.

Motion was made by Abts that the President and Secretary be authorized to borrow the sum of \$4,000.00 for a term of on or before two years at 4% interest from J. T. Costellow, to be repaid out of future income of the fair. Notion was seconded by Nyberg and passed.

Motion was also made by Abts, seconded by Nyberg that the Vice-President and Secretary be authorized to borrow the sum of \$2000.00 for a term of on or before two years at 4% interest from Elmer E. Guerber, to be repaid out of future income of the fair. Motion carried.

that \$2042.61 be transferred from the Washington County Fair Board Fund to the Washington County Fair Movers account to pay balance of accounts owed by the Fair Movers.
