He has booked Howard Johnson's stock for the 7th and 8th of August for \$2400.00 flat fee. Mrs. Johnson will act as secretary for the rodeo shows for \$100.00. Director names were discussed. Those mentioned were Ronald Vanderzanden and Dr. Pitman, Sr. More names will be submitted for appointment at the January meeting. Admission prices for the rodeo was discussed. Having one figure for admittance to the fair and rodeo was suggested. Definite price schedule will be set in January.

Mr. Jossy reported on his meeting with the Tax Advisory Board. Mr. Leutwyler put the figure of \$15,000 per year for 5 years in the budget for the fair. It was Mr. Jossy's feeling the Board was in favor of helping the fair and more support would be forthcoming from the county.
