CONTRACT TALKS

Gordon Scott offered the Fair Board a flat fee of \$275.00 for use of facilities previously used and in addition asked for use of the Arts & Crafts Building. Manager Jossy asked what kind of liquor would be sold. Scott said only beer.

After discussion the Board indicated that they would rather go on a combination flat fee and percentage.

1975 RODEO
RECOMMENDATION

The Rodeo Directors advised the Fair Board that they are proposing an RCA rodeo for the 1975 Fair. Orville Schoen said a delegation had visited with Bobby Christensen at the Pacific International Livestock Exposition and that Christensen agreed to do three night performances for a total of \$9,000.00. In addition the budget included: Furnish hay - 250.00, Court - 200.00, Diamond Ring - 300.00, Toilet rental - 150.00, Telephone-75.00, Shute painting - 50.00, Ambulance - 150.00, Posters and programs - 500.00, Rental of Sound Equipment - 150.00, Ticket takers - 100.00, Special events - 200.00, and Rodeo director expense - 180.00. (Total expense - \$11,305.00.) Income proposed was Rodeo Admissions - 2.00 x 2,000 x 3 nights 12,000.00, Concession income - 800.00, and Shute signs - 450.00 (total of \$13,250.00). Board asked what information had been gathered on N.R.A. rodeos. The committee indicated they were finding it difficult to find any contractors available.
