The Board of Commissioners work session talked of their legislative agenda, in which county fairs was an agenda item the Association of Oregon County's (AOC) is proposing legislation for the next session that would affect county fairs, Ms. Gray dispenses related information. Wade mentions that he is on a committee that is addressing the issues that were raised by the AOC. He has agreed to stay on the committee after he retires at the end of December. Also, Ms. Gray presented a letter from the Washington County Committee for Citizen Involvement, voicing concerns about the proposed changes to the Fairgrounds, Gray is staff for that committee. They would like input from fair staff. Wade asked to be placed on their next meeting agenda.

2. Consent Agenda: Margaret Garza gives report, goes over the financial position for to October 1998. General Discussion regarding financials.

<u>Chairman Thomas calls for a motion to accept the consent agenda, Lyle Spiesschaert so moves, David Lintz seconds, the motion passes.</u>

3.Bob Friedman exit poll / Research for Marketing: marketing survey presentation: Bill McKinley introduces Dr. Friedman. Dr. Friedman gives some background on his experience and his firms' experience on conducting fair surveys. Defines the nature of the two survey's conducted. Starts with the exit poll. The study should give an impartial picture. Then breaks down the demographic, "fair loyalists", "fence sitters", and newcomer. Many new fair attendees is approximately challenge is to retain them and convert them into repeater fair loyalists, They are also about a third of the respondents. The Fair has many educated, affluent visitors. The most impacting of exhibits are the traditional ones, like livestock. Dr. Friedman suggests reinforcing, and or doing something new having to do with livestock, and agriculture exhibits. The survey indicates that new fair attendees prefer livestock exhibits. Spiesschaert asked about the methodology of the survey, Dr. Freidman explained the process used. Wade mentions the positives about "fair food" also in the quality and in variety of the food booths. Dr. Freidman reviews the question about the quality of the fair. Generally speaking people will say it's the "same". People look at the attractions and exhibits. 61% stated they were satisfied with the livestock. The fair is competing with many leisure time attractions in the region. Generally the fair audience was satisfied or greatly satisfied. Audience perceived a value for their money. The Fence sitter is the critical draw, they must perceive value and interest to attend the fair. Overall, the fair seems to be a good one, but is in a critical position in that there are a lot of newcomers and making the fair attractive to these people is critical in making them fair loyalists. Spiesschaert asks that if there was a sure distinction between "grandstand" (rodeo) entertainment and "big name" stage entertainment. Dr. Friedman says that the respondents were clear about the question. Spiesschaert asks about not polling later in the fair day. Dr. Freidman says that most people at closing are not going to spend the time in responding to a survey. Spiesschaert saw many people that refused to take the survey and wondered if that was normal. Dr. Freidman says it was. General discussion on questioning criteria and results. Wade has a problem with high livestock ratings because of the "popularity" of

responding positively to that attraction as opposed to say, the carnival. Bob suggest not getting hung up in the methodology. Dr. Freidman now moves to the marketing survey for the fair. Two criteria, "spontaneous" and "prompted mentioning" the Washington County fair, both high. But a real distinction east and west of Aloha. East Side of county needs attention in raising awareness as in Beaverton, Tigard, Etc. Their needs to be heightened awareness on the East Side. Must find a way to get the Fair message across in advertising and promotions. Sandy Baker says you have in order to gain in the fence sitter/newcomer audience, the Fair loses the traditional audience. Dr. Friedman doesn't think you have to give up the old to get or retain the new. But must find a way to make the fair interesting enough to bring them back. Dr. Freidman talks about "persuasive" communications. Says there is a lot of information on this subject out there. Suggests that our advertising agency look into "persuasive strategies". Dr. Friedman talks about "selling" the fair to the "unserved" market. General discussion on all the options and demands on people's time that there is the summer. Wade mentions that fair attendance in the rural areas is almost 100% because that was the thing to do, not so in the populated areas. Wade talks about "building a better mouse trap" if your fair is to succeed in today's market. Dr. Friedman mentions again that livestock is a signature attraction at our fair, and is unique as attractions go and we should enhance our exhibits in that area. Wade mentions that several years ago we brought a focus group together to explore the unique high tech assets that Washington County enjoys. The fair board at the time rejected that option. Dr. Friedman mentioned the success that Lane County has had with the implementation of a focus group and their efforts in bringing high tech exhibits to the fair.

<u>4.Rodeo Report:</u> Cody Feinauer mentioned that they are getting prepared to go to the Las Vegas Rodeo convention in first week of December. No other comments

<u>5.Fair Boosters:</u> Garza passed out the <u>Fair Boosters minutes</u> and mentioned that the Boosters will not be meeting again until February 1999.

6.4-H Horse Fair: Sandy Baker is the new 4-H horse representative and gave report. Ms. Baker mentioned they are helping the campfire kids in their program again this year. In February there will be a function (tack sale) that will include vendor.

<u>7.Fair Report:</u> Bill McKinley gave report. The Carnival RFP went out to five contractors and we expect to have a contractor chosen by mid December. David Lintz asked if Funtastic's headquarters are in

Vancouver, McKinley responded that they are located in Portland. Paige Payne and McKinley have been talking about grounds acts for next years' Fair, (Pirates of the Caribbean, and another attractive dog act). This is the time of year that McKinley concentrates on the air show. He's been asked by Rose Festival coordinator Eldon Tishnor to prepare an alternative "war bird" option because of our not having a jet team for 1999. McKinley goes to the ICAS convention in Las Vegas about the time when Feinauer comes back from Las Vegas.

8.Marketing Report: Lisa Dupre gave report. More people want to be at the fair complex but we do not have the space for them. Lots of Christmas parties being booked presently. An ad is being placed in the Beaverton Chamber of Commerce business directory this year. This ad will not only advertise the Fair but also promote a display ad that mentions building rental options. Also, the Fair Complex is advertising in the Tigard Chamber of Commerce directory. John Thomas mentioned that the Tigard Times has a large circulation. Doing the same thing for Tigard. <u>9.Maintenance Report:</u> Albert Flanagan Jr. gave report. Most of the Fire Marshall's requests have been taken care of. The RV space is about 90% full in the barns. The team is doing regular maintenance repairs that go with our fall routine. Spiesschaert asked about the Cloverleaf repairs, Garza mentioned that the board authorized that the money be spent to do repair work given the findings/status of development progress.

(A) Waterline Easement: Wade talks about the 10.Old Business: waterline easement on the Quadrant property. Easement proposition goes to the county commissioners for review on the 10th of November. The bids have been mailed out today (Nov 4th) David Lintz clarifies the location of the proposed line with Wade concurring. They are leaving two outlets for the Fair and Wade had them placed at either end of the Fair grounds property line. Discussion on the logistics of the waterline project. (B) Association of Oregon Counties: Wade talked to the subject that Linda Gray brought up earlier in the meeting about the legislative community development process. Mentioned that Washington County is the only county that has two representatives on the committee, they being Dennis Mulvihill, as the county representative to the legislature, and Wade, representing the County Fair. Wade mentioned that our fair has a very good relationship with the county and that is not always the case. Three issues they are reviewing, one is the creation of enabling legislation to remove a fair board member for cause, like never attending meetings, as of right now, there is no mechanism in place to remove such a board

member. <u>Second</u>, to limit fair board members to two, three year terms. Wade feels that number one will fly but number two will not. Last issue, to conduct a management review process with the county commissioners, which Wade thought was an excellent idea. (C) Other: Spiesschaert asks that the staff respond to the letters that Linda Gray brought from the <u>Washington County Citizens for Community Involvement</u>. Wade speaks to the Bruce Campbell Boeing 727 project. General comments about getting the aircraft across Cornell Road and onto fairgrounds property.

10.New Business: (A) Travel Allocation: The subject of travel allocation for Fair Board members was reviewed by Margaret Garza. Garza makes the suggestion that we reinstate an earlier traveling compensation procedure that would reimburse board members for their traveling mileage. Wade recalls a conversation with Sue Oxendine stating that county counsel was the entity that ended mileage compensation. General discussion was held over a proper compensation solution for the voluntary Fair Board members.

Sheila Day moves that beginning in 1999, that Fair Board members be compensated \$15 per meeting, \$15 for related fair business, and \$15 for work at the fair to off set some expenses. Ken Leahy seconds the motion, the motion carries.

Further discussion on the compensation issue. Garza will bring proposal to county counsel to make sure we are proceeding appropriately with the now approved compensation policy. (B) OFA Convention: Garza informed on the dates and information for the OFA convention in Eugene is to be held January 8-9. Cody Feinauer mentions that the Columbia River Circuit finals will be held on the same weekend. Further, Cody Feinauer will not be giving his report in December in that he will be in Las Vegas attending the rodeo convention. (C) Letters of Appreciation: Garza mentioned the letters received by the fair and staff from 4-H and fair supporters from last year's fair are available to review. The file is located in front office. (D) Fair Theme: Garza talked about the fair theme for this year. Mentioned that a letter of solicitation for theme ideas was placed in the Argus. Asked if the Fair Board would like to provide input to the process. Discussion. Spiesschaert asked if we might not consider a "permanent" theme used year in year out, suggesting that we need to "reinforce" the theme on an ongoing basis. McKinley mentioned the success that the Western Washington Fair had in promoting, "doing the Puyallup" on an on-going basis. Discussion. Meeting to work with staff to come up with a theme. (E) Rodeo Dates for 1999: Garza brought up the issue of changing the rodeo dates first brought to us by Cody Feinauer. Feinauer related the benefits

of changing the dates to Wednesday through Saturday rather than Thursday through Sunday. Feinauer mentioned that the stock contractor saw his animals distressed with the hot Sunday afternoon show. Also the rodeo is in competition for the best cowboys with a bigger show in the mid west, and a change in the dates would make it more competitive in getting those cowboys to come to Hillsboro. The draft horses are willing to move their show to accommodate the rodeo as long as they stay part of the rodeo presentation. Discussion. Spiesschaert saw it as favorable as long as the staff finds a "draw" on the closing Sunday to compensate for the traditional rodeo date.

Lyle Spiesschaert makes a motion that the Fair Board accept the recommendation of the Rodeo Board which is to shift their Sunday performance to Tuesday night, and that the draft horse show eliminate their Wednesday night show and go with only one Saturday afternoon show. Additionally, that the Fair Staff find a major new draw for closing Sunday. Sheila Day seconds, the motion passes.

Sandy Baker mentioned the interest generated by the quality of the cowboys that come to the rodeo. Wade mentioned that PRCA needs to get their act together before there is any certainty of getting the quality cowboys, Feinauer agreed. Discussion.

<u>Chairman John Thomas calls the meeting adjourned 7:00 PM.</u> <u>Meeting adjourns to Executive Session</u>

EXPENSE PAYMENT FOR FAIR BOARD MEMBERS

OUESTION PRESENTED: Can the Fair Board members be compensated for attending the meetings?

BRIEF ANSWER: Yes, either as compensation or as expense.

<u>Discussion</u>: The Fair Board has exclusive business and financial management authority for the Fairgrounds pursuant to ORS 565.230. As such it can set compensation for the Board for attending meeting or other business related events. The Board can also compensate itself for business related expenses.

The Board has to decide whether it wants to pay itself compensation or expenses or both. Although only applicable to state boards and commissions, ORS 292.495 provides some guidance. This statute first allows compensation, where specifically allowed by law, of \$30.00 per day or part of a day for a board or commission member to perform official duties. The law then provides that expense of these officials may also be paid their "actual and necessary travel or other expenses actually incurred." As compensation, the Board would be paying itself for a service. As expense, the Board would be paying itself for expenses incurred. There may be some tax implications that are beyond the scope of this memorandum.

If the Board uses the \$15.00 payment as expense payment, the Board will have to make a determination that the amount is an accurate estimate of an average expense of attending the meetings. Generally, mileage and other expense are calculated on actual mileage traveled and other expense incurred. However, the Board has the authority to streamline the process and determine if it would be more efficient and cost effective to provide a flat expense rate. The County Board of Commissioners does this by providing itself with a stipend for private vehicle usage. Also, the Planning Commission is compensated for an average of miles traveled for the number of meetings each member attends. The County also allows a per diem travel rate for meals, which does not use actual receipts. If the Fair Board decides to uses this payment as repayment for expenses, it should adopt some findings about what the actual expected expense would be, how the proposed payment matches that expense, and how the flat fee is more efficient and saves money and staff costs.
