RAINIER SHOWS CONTRACT 1976

Manager Jossy reported that the carnival contract with Rainier Shows has been negotiated. Terms as follows: 20% of the gross - less liability insurance and \$10 for each concession or booth operated for the week. The gross is a 5% increase and the concession a \$5 increase.

The 1976-77 county fair budget was reviewed line by line and each item budgeted.

Board and Management agreed Pat Roberts show would serve as good entertainment for the \$750 offered by Jack Roberts Agency. Jossy will try to get Roberts for a Wednesday matinee and evening performance (August 4). Tualatin Valley Harmonaires offered to entertain for a \$100 fee. Board felt T. V. Harmonaires would also fit in well with the bicentennial fair.

LETTER OREGON LABOR BUREAU Correspondence has been received from the Oregon Bureau of Labor, Bill Stevenson, Commissioner, stating that the Wage and Hour Commission has no jurisdiction over City, County, State, or Federal employees. Therefore, as long as the minors hired by the fair board are being paid public moneys, they are exempt from coverage.

VanDyke also said they would consider performing in the arena and giving free kiddie rides in wagons.
