## FAIR BOARD MEETING

## THURSDAY NIGHT, FEBRUARY 19, 1931

Officers present at this meeting were President Banks, First Vice-president Minton, Second Vice-president Hesse, Treasurer Kraus, Secretary-manager Moore, and the following superintendents: Mrs. McKercher, Mrs. Vincent, Mrs. Bentley, R. Hornecker, Frank Schulmerich, C. W. Craft, Prof. R. M. Adams, and Assistant County Agent Averill.

Minutes of last meeting read and approved.

Moved by Minton, seconded by Hesse, that the same superintendents be appointed for the coming year as acted last year, with the exception of Mr. Kraus for the boys and girls club work. Motion carried.

The secretary was instructed to ask J. L. Batchelar, Hillsboro, Route 1, to act as superintendent of the Guernsey division.

After some discussion it was decided to leave the swine department the same as in previous years.

Moved by Minton, seconded by Hesse, that the judges score be put on each Grange booth, and that first, second, third and fourth ribbons be awarded and the money divided equally the same as before. Motion carried.

Moved by Minton, seconded by Adams, that a \$10.00 prize be awarded for showmanship in the cattle, sheep and hogs division, provided there is enough entries to make a contest. Motion carried.

It was decided that on page 12 of the premium list under "General Barm Exhibit" heading the first sentence shall read: "Farm exhibits must be grown by exhibitor, and all exhibits must score 66 points or more in order to participate in premiums."

Mrs. E. E. Bentley, superintendent of the art department, proposed the following changes:

In Class 1, the heading shall read "Amateur Oil Painting, Original Productions".

In Class 2, the heading shall read "Amateur Water Color Painting, Original Productions."

In Class 3, the heading shall read "Amateur Pastels, Original Productions", and in this class articles 14 and 15 shall be delected.

In Class 4, no change at all.

In Class 5, the heading shall read "For Children 18 years of age and under", and the following articles be listed: 18. Landscape, pen and ink or pencil.

19. Landscape, oil painting.

20. Pen and ink or pencil sketch.

21. Poster.

22. Water Color Painting.

Class 6 to be discontinued entirely.

. Moved by Minton, seconded by Hesse, that the changes as recommended by Mrs. Bentley be adopted. Motion carried.

Mrs. McKercher, superintendent of the domestic science department, proposed the following changes in her division: That in Article 15 the words "Baking Powder" be added

after the words "Doughnuts".

Under "Canned Fruits, Vegetables and Meats", that under Articles 22, 23, 24, 25, 26, 27, 28, and 31, the words "Largest and" be deleted; and the last of each article read "not less than 6". It was moved by Minton, seconded by Hesse, that these changes as recommended by adopted. Motion carried.

Moved by Hesse, seconded by Minton, that in Division 1, Domestic Art, the second paragraph consist only of the first sentence; - "Articles must be the handwork of the Exhibitor", as recommended by Mrs. Vincent, superintendent of this department. Motion carried.

It was moved and seconded that the Club Specials and the manner of awarding them in the 4H Club work be left to the County School Superintendent and the Assistant County Agent. Motion carried.

Mr. Averill suggested that it would be better if Children's Day be Friday instead of Thursday, but after general discussion it was decided to leave it as it has been on Thursday, Mr. Minton stating that children's day would be better attended if the County School Superintendent put more enthusiasm into it beforehand.

No further business appearing the meeting adjourned.
