The meeting was called to order at 8:00 P.M. by the President, Al Lindow.

Those present were Al Lindow, A.B. Abts, Earl Simantel, Ed Ball and Ethel Fleshman.

Mr. Mason and Mrs. Haase representing the swine group approached the board with

- (a) hopes that more premium monies could be appropriated for the swine house
- (b) that two new breeds could be added this year.

The board concurred that with the financial indebtedness of the fair board as it is now that nothing can be done at present but as soon as the debts are cleared up that there would be a good chance of increasing the premium money.

Motion made by Mr. Abts, seconded by Mr. Simantel that (a) Chester White & (b) Black Polled China could be added to the premiums and shown this year. Motion carried by unanimous vote.

A model of fair bard 40x48x6 - 1920 sq.ft. was displayed by Mr. Krahmer of the T.V. Coop. Made of steel and wood construction with open ends the cost for materials would be \$1100.00 all inclusive with exception of footing and labor.

Mr. Roy Harcourt of the TVRBA submitted the following additional figures to construct a similar type building but of wood construction that would cost considerably more to construct and push up the labor cost and would not in the end be as strong or as lasting a building.

\$315.00 framing material \$366.50 ship lap \$467.00 roofing material All decision tabled for further consideration.

The Rabbit Breeders askedpermission of the board to use the Fair Ground on April 25 and 26 for the Spring Rabbit Show. Permission granted.

Minutes of the January 5th meeting read and approved on a motion by Earl Simantel, seconded by Tony Abts and carried by unanimous vote.

Mr. Abts moved that Ethel Fleshman be hired as secretary starting as of January 1, 1959. Motion was seconded by Mr. Simantel and carried. Included in the motion was that Mary Hadley retiring secretary be paid final salary for the month of January also.
