PUBLIC WELCOME ...

The audience was welcomed and invited to speak concerning any item on the agenda.

EXECUTIVE DIRECTOR

Sprecher reviewed the recruitment process for those in attendance. Following the interview, it was unanimous to authorize Sprecher to approach Caleb Wade and negotiate terms for possible employment. Sprecher recommended hiring Wade at \$31,500 annual salary, with a salary review and evaluation following the fair.

MOTION: MOVED BY HOMER SPEER, SECONDED BY JEANNE LEESON, TO ACCEPT THE CHAIRMAN'S RECOMMENDATION AND HIRE CALEB WADE FOR THE POSITION OF EXECUTIVE DIRECTOR OF THE WASHINGTON COUNTY FAIRGROUNDS. MOTION CARRIED.

At this time Caleb "Cal" Wade was introduced to the audience. The following information concerning Cal's background and experience were read: Associate of Arts in Agriculture from Pierce College, Bachelor of Science in Agriculture from Fresno State, owned and ran a dairy farm 10 years, shown and judged animals at fairs, Treasurer of Josephine County Dairy Herd Assn., President 1966 Josephine County Young Farmers, 4-H member 13 years, 4-H leader 10 years, served on Extension and FFA Advisory boards, ringman at fair auctions, in banking industry 20 years as vice-president, branch manager, and senior bank officer, 1983 President of Grants Pass Chamber of Commerce, Board of Directors Grants Pass Visitors/Convention Bureau, Josephine County Airport Board, aircraft owner, member of Pilots Assn, Chairman 1978/79 Oregon State Marine Board, owner and manager of a restaurant resort, owner and operator of Rogue River Rafting Co., part of Barnstormers Little Theater, member of Josephine County Fair has been a

gold medallion fair for many years and the facilities are known to be some of the finest in the State.

CHAIRMAN'S EMPLOYMENT

A memorandum from county counsel indicated it was possible for the Fair Board to retain the services of the Chairman for a couple of weeks to train the new director.

BOOSTERS ·

The executive board of the Boosters met in January. Their regular meeting dates were changed to the second Tuesday of the month. They also expressed an interest in removing the old red storage building and will continue working towards obtaining lights for the Main Exhibit Building.

RODEO BOARD

Rocky Williams, Rodeo Board Chairman, reported the minutes should reflect Prize Money as \$7,000. He also thanked the board for his trip to the IPRA Convention in Tulsa. Jenny VanKoll, court coordinator, introduced the Fair & Rodeo Court: Princess Kris LaFollett, Princess Jodi Carlson, and Queen Michele Holmes. Jenny noted the girls have attended 4 functions to date. The board expressed their appreciation and thanks to Jenny VanKoll for the work she's doing.

WALKWAYS

Discussion was held concerning asphalting the fairgrounds walkways. Sprecher obtained quotes from four engineering companies and after checking references, she recommended Development & Construction Services for the project. It should be noted Development & Construction Services submitted the lowest quote.

MOTION: MOVED BY HOMER SPEER, SECONDED BY JEANNE LEESON, TO AUTHORIZE THE FAIR BOARD CHAIRMAN TO RETAIN DEVELOPMENT & CONSTRUCTION SERVICES TO ASSIST IN ENGINEERING THE ASPHALTING OF WALKWAYS PROJECT, SUBJECT TO EXECUTIVE DIRECTOR'S, CAL WADE, APPROVAL. MOTION CARRIED.

4-H BARN ELECTRICAL UPDATE

Bentley Electric submitted the lowest bid and has completed an electrical update of the 4-H Barn. The board gave approval for a bare wire from the barn to be repaired.

LANDSCAPING

Epler Farms donated 19 Red Maples for landscaping along 34th Parking lot. Jeanne Leeson is working on a story for the paper concerning the generous donation. HJCCC brought out a backhoe on short notice and helped plant the trees. Thank you letters have been written.

Mr. Knapp, PCC landscape instructor and one of his students toured the grounds and are donating their services to create a landscape design for the new entrace and sign area.

PREMIUMS

MOTION: MOVED BY HOMER SPEER, SECONDED BY JEANNE LEESON, TO APPROVE THE PROPOSED PREMIUM INCREASES IN THE POULTRY, SHEEP, WOOL, AND RABBIT DEPARTMENTS AND 4-H DIVISION. MOTION CARRIED.

Sprecher explained all increases were modest but could be increased again the following year.

CITY PLANNING MEETINGS

Fair Board members discussed planning meetings held concerning development of a recreational facility on the property adjacent to the southeast corner of the fairgrounds.

DAIRY CATTLE SUPERINTENDENT

MOTION: MOVED BY HOMER SPEER, SECONDED BY JEANNE LEESON, TO APPOINT LOUIS BAXTER AS OPEN CLASS DAIRY CATTLE SUPERINTENDENT. MOTION CARRIED.

DECORATIONS-

Sprecher is working towards purchasing wind socks as decorations during fair week.

PHONES

GTE is installing three additional public telephones and relocating the exisiting phone booths for easier access. There is no charge to the fair-grounds for this service.

OUTDOOR LIGHTS

Two outdoor lights will be obtained from the Rodeo Board and could be placed in the warm-up arena.

FAIR:TRAFFIC

Sprecher proposed a gravel road extending from the present 34th Avenue to give additional access to the pit area. She has met with Chief Woll and Capt. Shook of the Hillsboro Police Department concerning traffic patterns during Sunday release times. Both Woll and Shook were receptive to the idea. The board agrees the road is needed and to move forward if the cost isn't prohibitive. Fencing and the proposed road are projects the Boosters may be interested in. The option will be exercised to allow parking in the Sports Complex and Port of Portland clear zone.

TIME CLOCK

A time clock was purchased for security checks and will be put in place.

SHOWER/TOILET TRAILERS

The Rajneesh have indicated the trailers are still available. Permitting the trailers would fit in with long range plans and the possible sewer problems and permits are researched. Sprecher will negotiate for purchase.

LOTTERY

Sprecher indicated after attending the Oregon Fairs Association convention workshop and reviewing the materials and regulations, it appears Washington County Fairgrounds would not have a good chance of receiving funds. It was agreed Washington County would not compete for funds this year.

MAINTENANCE SHOP

Sprecher recommended a new shop at an estimated cost of \$12,000. The board agreed staff should look into the project further and proceed.

OPERATIONS REPORT

January projects included sprayed round-up at rodeo grounds, repaired and painted livestock panels, repaired major water-line break in roadway, painted restroom floors in Cloverleaf Building, started repair and painting of picnic tables and benches, planted 19 Red Maples in new parking lot, assisted Bentley Electric in 4-H Livestock barn electrical update, completed ribbon boxes, and painted directors office.

Upcoming projects will be completing electrical work in 4-H Livestock Barn, painting 4-H Livestock Barn, preparing and painting Grandstand, continuing repair and painting of picnic tables and benches, and landscaping the corner of 34th Avenue new entrance.

It was noted staff should focus on utilities. Ticket booths are adequate for this year but should consider new ones soon.

JAIL NOMINATION

Washington County Historical Society wrote a letter in support of the nomination of the jail to the national register. There will be a presentation to the State Advisory Committee February 21, 1986, in Salem,

PROMOTION

Jeanne Leeson proposed placemats promoting the fair and providing them to restaurants at no charge. Williams, Rodeo Board Chairman, said their board had tried a similar project but west county restaurants were not receptive to the idea. Leeson said she would phone restaurants to get their reactions.
