JAYCEE HAPPY DAYS RENTAL

The Hillsboro Jaycees would like to use the fairgrounds for 11 days this year. They will start moving in Tuesday, June 26 along with their carnival operator, Blake. They will hold two fireworks displays this year - one on Sunday and one on the 4th of July. Hopefully the fairgrounds will be cleaned and vacated by July 6th.

The Jaycees were informed of the upcoming drainage project and of possible inconvenience to them, if the weather is uncooperative and the project cannot be completed.

Holland asked if the Jaycees are willing to donate labor or other services in lieu of rent monies. Semm responded not at this time.

Semm commented that the Jaycees are going to relocate and asked if the Fair Board would consider the possibility of a Jaycee building (50' x 75' two story structure with completely finished, heated downstairs) being located on fairgrounds property. Arrangements could be made for sharing of rental, utilities, etc. Jaycees would exclusively use the upstairs with the downstairs available for Fair Board usage and rental.

Hesse explained the Fairgrounds Boosters and Fair Board would like to hold a destruction derby and man concessions during the Happy Days event to raise money for the fairgrounds. The Boosters and Fair Board will donate their time to help make the event successful and profitable.

MOTION: MOVED BY RALPH HOLLAND AND SECONDED BY CHARLES COLEGROVE TO ACCEPT THE HILLSBORO JAYCEES RENTAL OFFER OF \$3,500 PLUS PAYMENT OF ALL POWER AND GARBAGE FOR USE OF THE FAIRGROUNDS (JUNE 26 THROUGH JULY 6), CONTINGENT ON THE FAIR BOARD HAVING EXCLUSIVE USE OF THE GRANDSTAND WITH CONCESSIONS FOR A ONE DAY MAJOR SPORTING EVENT IN CONJUNCTION WITH HAPPY DAYS. MOTION CARRIED.

HORSE SUPERINTEN- Barbara Jackson, the newly appointed Horse Superintendent, was DENT introduced to the Fair Board.

Jackson feels the Fair Board should hold an OHA approved open class horse show. The \$1.00 charge to non-members, except in the halter, and equitation classes, will be collected by the show management. Marge McCornack, Horse Steward, clarified the OHA fees are appropriated as follows:

- 10% Convention Committee
- 15% Returned to show for prizes, ribbons, trophies, judges card, etc.
- 35% Oregon Horseman Publication our show in included in that publication
- 45% Research and development fund at Oregon State U.

Jackson would like to set the entry fees at \$4.00 for conformation and \$5.00 for performance, with a post entry of \$2.00.

The OHA tally will be taken on Sunday and a check sent by the fair office after the tally to OHA.

Boyer felt the \$2.00 post entry fee would be disadvantageous for goodwill and collection.

Jackson commented that good quality judges are now being sought in September and wondered if her duties as superintendent were over right after the fair. Hesse commented that the superintendents' appointments are made for one year and over after fair. Boyer recommended that Jackson could recommend a judge's name to the fair office. The office will then either contact that judge or make sure the superintendent for the next year has access to the recommendation.

Because the ribbons and trophies are purchased with sponsor donations, the Fair Board recommended the superintendent keep in touch with the office as per superintendent guidelines. All contracts, bills, obligations must be approved by the Fair Director.

Hesse will recommend the premium money be raised for first, second and third places. A decision will be made during a special meeting held later in February.

A horse show secretary has been appointed, Flo Anthony; she will work closely with Jackson.

MOTION: MOVED BY RALPH HOLLAND, SECONDED CHARLES COLEGROVE TO APPROVE THE OPEN CLASS HORSE SHOW PAYMENT OF \$25.00 TO THE OREGON HORSEMEN'S ASSOCIATION. MOTION CARRIED.

POOLE REPORT

Gary Poole was unable to attend and will provide an update on the multi-use arena at a later date.

DESTRUCTION DERBY BIDS

Bill Amick presented a proposal and Ron Ail presented a sealed bid to the Fair Board for their consideration. Numbers were drawn to decide presentation placement.

Amick, A & P Sports, after the settling of personal affairs will now have more time to devote to providing a successful destruction derby. Amick stated the cars racing during the fair derby will receive points used by the Portland, Speedway. The rules are now compatible for all who race, rather than icompatible with Washington County and Portland. The rules will remain the same as in the past derbies and the area clean up will be done immediately following the event.

Ron Ail, Northwest Sports - a subsidiary of Valley Sports, related his operation of derbies in Washington, California and Oregon. He would like to give the residents of Washington County a good show - 1 hour time trials and 2 hour show. Northwest Auto Association will supervise the event. He would like to see mostly stock autos used rather than the expensive, metal reinforced ones. He will run a derby for Multnomah County Fair on Thursday and Friday - Washington County will be on Wednesday. He has operated fair destruction derbies for the Oregon State Fair, Grants Pass, Spokane and Walla Walla, Washington and the Southwest Washington Fair in Centralia. He is no longer affiliated with the Portland Speedway. He has not run a derby for a county fair in Oregon for approximately 15 years.

The Fair Board asked both men questions about safety rules, admission prices and security.

The Fair Board thanked Bill Amick and Ron Ail for their presentations and will schedule time for further discussion at the March 7 meeting.

OPEN CLASS SHEEP SHOW Hesse reported letters have been received asking the Fair Board for the addition of an open class sheep show.

Hesse has been in contact with George Horner to obtain a Draft Horse Show put on by the Washington County Draft Horse Breeders. The horses will number 24 and will be on exhibition in the horse barns.

The 4-H Horse Show is over Tuesday night. Open class dairy goats enter on Wednesday.

Because of the already crowded exhibit barns (goats and horses together) it will be necessary to allow early release of the open class dairy goats. Hesse will meet 2/8/79 with superintendents of horse and dairy goat divisions and ask dairy goat exhibitor cooperation in vacating the barns on Friday noon, so that sheep exhibitors may move in afternoon Friday.

MOTION: MOVED BY RALPH HOLLAND, SECONDED BY AGNES DELASHMUTT TO APPROVE FOR A ONE YEAR TRIAL PERIOD DIVISION H DESIGNATED AS OPEN CLASS SHEEP FOR A ONE DAY SHOW FOR THE 1979 FAIR. MOTION CARRIED.

COLEGROVE REPORTS Colegrove reported his contact with the members of the milking parlor committee. The committee will meet February 28th at the fair office to discuss the construction of a milking parlor for the 1979 fair. Dan Lowry, Washington County Extension Service will attend along with a Surge (milking parlor building company) representative.

Joe Evers sent correspondence to Colegrove. Evers stated the Holstein Club will match premium money for youth with dairy stock as he feels the premiums are too low. He asked that the 4-H youth be allowed to show in open class - same animal. He also feels a milking parlor could be built for \$20,000 with donations from local dairyman. DeLashmutt commented that the double showing is diametrically opposed to 4-H rules and regulations. The 4-H youth may, however, show one animal in 4-H and a different one in open class and this should be encouraged. Hesse will draft a letter to Evers including Board input from this meeting.

Fair Board Would like the milk parlor committee to visit the Clackamas County Fair's milk parlor facility and to present several alternatives with specific cost. Fair office will write and send out a meeting notice to the appointed milk parlor committee and other selected persons.

FAIRGROUNDS BOOSTERS DeLashmutt reported the Boosters are applying for a non-profit postal permit. The Boosters are actively soliciting saleable items for the auction to be held July 21st. The Auction Chairman is Wally Crawford and will be run by the Oregon Auctioneers time donation. The Boosters priority list will now include the multi-

use arena. The drainage is now the top priority. DeLashmutt noted that to date the Dairy industry has not joined the Booster effort to get the drainage project accomplished.

The next Booster meeting will be February 28th - 8:00 p.m. at the fair office. The Fair Board is invited to attend and actively seek booster membership.

DeLashmutt visited with Ken Lewis and Fred Boyles to cooperate in the obtaining of a Rodeo contractor. March 10th a decision will have to be made for the contractor. She recommended the contractor be both NRA and ORA approved.

Chairman Boyer appointed DeLashmutt to handle information from the Rodeo Board, attend Rodeo Board meetings, and assist in whatever way necessary to make the Rodeo a successful one.

MANAGER'S REPORT The new fairgrounds logo designer has not yet submitted logos for approval.

* PGE

Hesse called Portland General Electric to assess our electrical problem in the main exhibit building. PGE feels the transformer is not a problem. The problem is old wiring and/or overwiring. Fluorescent lighting to replace the present light fixtures would be an asset.

* DRAINAGE

Hesse met with John Junken, Chief Assistant County Counsel, to discuss our drainage project funding. He felt we should submit a request to the Public Contract Review Board for a specific exemption under OA rules 127-10-160. Because of the great number of donations, it would be difficult to prepare a proposal for public bid.

LIVESTOCK ASSN. DONATION

DeLashmutt reported that the Wishington County Livestock Assn. has voted to donate \$1,500 to help in the construction of a livestock wash rack to be ready for Fair, 1979.

She also mentioned a Tualatin Valley 4-H group has disbanded and donated \$254.00 toward the wash rack.
