Minutes of a regular Fair Board meeting held at the fair office January 16, 1980.

WELCOME, CONGRATULATIONS Chairman Boyer welcomed everyone present. New Fair Board member, Mike Swan, was introduced and Colegrove congratulated on reappointment to the Fair Board.

MOTOCROSS INPUT

Boyer noted Babich had taken exception to minutes as printed and mailed. Boyer advised the pertinent information in the minutes is accurate and included. Accusations, innuendos and otherwise impertinent information is omitted.

Babich stated he was primarily concerned with noise nuisance and the DEQ noise levels. Because DEQ has no set noise level standards, it is hardly possible to base an informed decision on DEQ information. He felt another trial is justified to better test the noise during light air time, when neighbors are out in yards, windows are open, clear weather, etc.

Boyer noted that letters addressing the motocross all related no objection to Fair activities and general fairgrounds usage. The noise created was only for a short term on an infrequent basis. Largest noise in area seems to be the airplane noise. Are citizens complaining because of the motocross idea or only the motocross noise?

Phillips was home on the trial day, heard nothing because he felt it was rainy and heavy air. He asked whether the racing is regulated, if so what are the regulations; what dates are assigned: how will the practice racers be handled, if present on fairgrounds for unauthorized practice. When he moved into the area, the airport was already established. The motocross citizen input will involve the community in the decisionmaking.

Mentioned was the reason for the interest in motocross- a citizen group residing in Washington County requested usage of the fairgrounds to hold the event. The Fair Board, of course, is anxious for ideas and year around events at the fairgrounds. The motocross decision will not be made until another trial race results and reactions are considered. No regulations, dates or security plans have been assigned.

Babich stated his objection to any extra noise (noise nuisance) that penetrates within his home.

Heideman, resides closest to the fairgrounds, added any noise that was not present when he moved in, he will take a hard look at - a mechanized event causing noise discomfort.

MOTOCROSS INPUT

Heideman has no objection to motocross races, but not every weekend if the noise in fact proves objectionable.

Babich asked about the cost/benefit factor for the fairgrounds. Boyer responded the mutual benefit of the community, neighborhood and fairgrounds must be considered. The monetary benefits would be on the positive side, with no actual figures available until a program is developed. Babich added he did not wish to insinutate inaccuracy in the Board minutes, only that not enough detail was printed.

Jim Susbauer expressed concern about motorcyclists using the fairgrounds, particularly along the railroad track for practice without permission. He also felt 3 or 4 events per year would be acceptable. All agreed the security of the fairgrounds is most important along with the unwanted noise of the motorcyclists.

Pflug remarked that another trial run will be run at a maximum time for noise travel; notification of the trial will be given; negative aspects of the motocross will indeed receive attention.

Babich was asked to continue as the liaison for his neighbors.

Babich agreed and added he hoped the next trial would be an all out, full scale event so that all aspects will come to focus.

Boyer thanked all for attending and their thoughts on the motocross.

CT EN INPUT

Bob and Julie Duncan, Viking Sewing Center, attended the meeting to share with the Fair Board their concerns and thoughts of improving the fairgrounds and Fair. Julie felt the Board should try to put a measure on the ballot to raise funds for a multi-use building on the fairgrounds. She visited with 4-H ladies and received comments from many 4-H people would be more than glad to help and support the measure. Could an EDA grant be gotten? Can the business district close shop for one day so all employees could attend the Fair?

Boyer explained the steps for a ballot measure, problems with obtaining an EDA grant. A Booster membership was also discussed.

Julie added several ideas for special events during Fair.

Jerry Mee, Mee Productions, asked about the Fair entertainment budget and discussed possibility of professional talent.

The Board appreciated the time the Duncans and Mr. Mee took to come the the meeting and expressed their enthusiasm was stimulating and hoped the Duncans would continue their support and ideas for improving the fairgrounds.

HORSE DEPARTMENT IDEAS

Punky Benson, Horse Superintendent, received a big Thank You for agreeing to again head the horse department. Punky summarized her suggestions: more than one person is needed to handle the entire horse activities; perhaps Sunday could be designated a benefit show and handled by volunteers with proceeds going toward horse facility improvements; improvements needed are more box stalls. Benson has already contacted three people to help with the horse department and a volunteer to run the Sunday show. She will coordinate all activities. The Sunday show will not be listed in the premium book. There is possiblity of arena ground improvements. Perhaps money donated toward horse facility improvements should no longer remain unused for possible multi-use building construction, but rather

HORSE DEPARTMENT used to benefit those who donated the money. Additional horse stalls have been needed for years. Portable stalls could be built with funds available, also need for horse show office was discussed.

ENTERTAINMENT REPORT

Pflug did not spend a lot of time on entertainment discussion at the convention with professional talent agents. He felt if talent is hired it must be of superior quality and a quality facility should be available. Without funds or facility the fairgrounds will have to look elsewhere. Fine talent is available in the community. Several sources, including the local high schools, will be investigated.

THREE PERFORMANCE RODEO FOR 1980

The Rodeo Board recommends a three performance rodeo for Fair 55. Contract fee for the extra day is nominal. Pflug asked if a Saturday afternoon performance would conflict with carnival promoters. horse department classes and attendance overall. Because of the afternoon time frame of 2:00 p.m. general feeling was the 4-H, FFA people would have a better chance to attend along with small children and elderly. (Exact time to be decided.)

The idea of a separate north gate for Destruction Derby and Rodeo admission: Would additional security and restrooms be needed? Fair pass holders shall be considered in the admission price, if the additional gate is added.

4-H CORRESPONDENCE
