Motion was made by Sahnow that abts be elected treasurer and that the nominations be closed and the Secretary instructed to cast a unanimous ballot. Motion seconded by Nyberg and carried.

Ed Ball was then appointed manager by the fair board with the salary of \$1200.00 per year.

Mary Hadley was appointed secretary with the salary of \$600.00 per year.

The minutes of the previous meeting were read and approved.
