RODEO BOARD PROPOSAL

SERIAL LEVY

Chairman Springer has visited with County Commission Chairman Ray Miller regarding funds to finance a special serial levy for fair. Commissioner Miller told Springer the Fair Board could not receive the levy funds until after June 30, 1977, (new budget) and to commence on the leg work.

Suggested theme entries were read to the Fair Board. Winner in the contest is Mrs. Fred (Jessie) Weller or Tigard. 1977 County Fair theme is "Blue Ribbon Days".

1977 PREMIUM BOOK

Mrs. Hesse suggested enlarging the county fair premium book by eight pages to allow for livestock entry forms, financial explanation of the funding of the fair, entertainment page, and fact sheet on ticket prices. The Fair Board unanimously encouraged the idea. Selling ads for the 1977 book was discussed. Mrs. Hesse will sell for the premium book and was encouraged to find help if needed or desired.

MOTION. MOVED BY JOE EVERS, SECONDED BY JERRY BOYER TO HAVE ADELINE HESSE SELL ADS FOR THE 1977 PREMIUM BOOK AND TO RECEIVE 25% FOR THE SERVICE. MOTION CARRIED.

PRIME STOCK SALE

Springer said funds for prime stock sale will be turned in soon. Accounting has been completed.

ELECTION OF OFFICERS

Election of officers could not be conducted because Board vacancies were not filled by the Board of County Commissioners as provided in Oregon State Law 565.210.
