

Meeting was called to order by Chairman Thomas.

The Public was welcomed by Chairman Thomas. This time is provided for members of the audience to comment on any item(s) on the agenda. Audience members are also welcome to comment at the time the agenda topic is being discussed by the Board. It is respectfully requested that those addressing the Board state their full name for the record.

NEW BUSINESS: PROPOSAL BY BOB FRIEDMAN REGARDING HIGH TECH DISPLAY

Chairman Thomas introduced Bob Friedman and the proposal. Friedman thanks Chairman. Friedman gave introduction of individuals: Dave DeMarkey and himself, and overview of his firm, Research for Marketing, Inc. Cited individual backgrounds, fair experience with emphasis on the following fairs: Texas, Ohio, Arizona, as well as involvement with Walt Disney Imagineering. Friedman indicated he had known Wade from previous working opportunities doing research for the Washington County Fair on such items as Market Surveys and Exit Poles. These items helped the fair understand who came to the fair. Friedman continued to state he was here because Wade had indicated to him the number of attendees at Fair were going down and that we needed not to change what were doing, because we have a good fair, but rather, that we needed to look at ways to add value to the Fair. Friedman is suggesting that a focus groups be conducted with high tech executives in the county. This focus group stemmed from a visit to Marin County. Gave overview of similarities between Marin County and Washington County. The Marin county fair has been successful in bringing youth to the fair through the schools and by linking high tech industries as exhibitors. Marin County has 10-20 high tech companies that exhibit a variety of computer software and hardware. Youth are given a variety of class awards for their involvement. This linking allows for home grown talent. local firms and local students to be exemplified. This brought a new segment of fair comers that was not coming to the fair in previous years. This is a model for many Fairs, especially for the future, i.e. the Washington County Fair since we have a big base of high

tech firms and have many students, 20 classes being offered Washington county high schools and other related computer projects.

(1) Need to diversify the fair to make sure it is connected to the 21st century. So a focus group was held with these high executives. A lot of discussion back and forth holding something like this. People are willing to commit with reason (only twelve people, 1200+company's in the county) for opportunities to: 1) show product, exhibit product, make a civic contribution; and 2) give kids recognition for involvement in program development in their schools; while at the same time (3) drawing a lot of people to the fair, that might not ordinarily come, due to change of interest that is available at the fair.

What we are proposing to you today, is that we implement the recommendations made to you out of this focus group. Recommendations were that we go forth and establish this attraction in 1997. That we should concentrate on smaller high tech companies because there are many of those in town and they were the ones that were most interested. That we begin to contact the schools to solicit interest in this class of awards that would be given out for superior computer programming. Then that we get this implemented and we have a new attraction at the Fair.

The proposal has several steps for implementation, it is organized, it is laid out, and we think it will be successful, and at the same time increase the number of attendees that otherwise would not come to fair.

ENTERTAINMENT OF QUESTIONS BY THE BOARD:

Lintz: When was this proposal prepared?

Friedman: Prior to December, after fair, after the focus group.

Lintz: Any reason why it wasn't in the packet of information?

Wade: It was given to you in your September packet.

Lintz: Is this the one you referred to?

Wade: Yes.

Leahy: How many company's in the focus group?

Friedman: We met with 12 firms and about 4 showed interest. We think there is a lot of interest, especially in small business, getting awareness, number of people that come to fair.

Gray: It says in here you had seven.

Friedman: Okay 7, I forgot.

Gray: What type of networking capabilities would we need?

Friedman: We would not need a network. We would need one building, i.e., trailers, buildings. This is in the planning stage. Probably portables would be brought in.

Lintz: You then, just wire them?

Friedman: Wire them, yes, properly, temperature controlled, arranged for plenty of room for traffic. Friedman thinks this is a real potential for getting kids involved and this becoming a center of attraction in schools as in Marin County.

Thomas: What would be the expense of something like this for setting up?

Friedman: We are proposing to implement the plan and since we have not done this before, there is a lot of variables we cannot pin down. To the point of implementation the budget would run between \$ 7 - \$10,000. That is for all the footwork, discussions, coordination and so forth. Staffing would be by the companies and the students. Cost to the fair would be the structure, electricity and the publicity. We are not trying to replace the existing fair, I just want to reiterate that. We want to add to the fair, by brining an attraction that will draw people that wouldn't otherwise come.

Leahy: How much square footage for a facility like this?

Thomas: Were you involved in Marin County?

Friedman: No, not involved. Had many discussion with the Director regarding the overview of the program at Marin County. Here we would expect 7 - 9 exhibitors, and not sure about the square footage.

Lintz: Do some of these companies have mobile displays?

Friedman: Yes, they all go to trade shows and sell products. Emphasis on educational program, and exposure for higher tech companies.

Gray: If all these companies have mobile units, then do they necessarily need a building or space?

Friedman: They go to conventions where they purchase booth space.

Williams: Will you award to kids; and when?

Friedman: We'll give awards before fair.

Williams: Based on innovation of Program/technology? Or capitalizing on something that has been done already: What is the basis for the judging?

Friedman: Experts to recruit instructors and executives; and these experts to set standards for judging.

Williams: What will be the compensation for these high tech programs?

Friedman: Recognition is the reward for the kids, industry will do in-kind items such as hardware to give out to the winners.

Lintz: I think this in principle makes sense to have some element/form of High Tech at the fair. Does your consulting fee take it through the production aspect?

Friedman: When you say production, please clarify?

Lintz: The ultimate event.

Friedman: Yes. The ultimate event?

Wade: It doesn't take into consideration the cost of the production, but his consulting would go all the way through.

Friedman: Yes, consulting would go all the way through with an advisory committee and with the linking of the schools, organization of the awards for the kids. In terms of the actual physical structure and the electricity, no.

Lintz: Certainly you're not, I understand that. Okay. It would be modeled after the existing?

Friedman: Yes, after Marin County. This director is very willing to help with time and give of his knowledge and I've actually been there and looked at it.

Lintz: Truly then it is the organization of a new element of display?

Friedman: Yes exactly, but this has a purpose.

Lintz: So do the other displays.

Friedman: Yes, this has a purpose that has real need and at the same time brings in a new segment of the market that otherwise would not come to the fair (people with higher disposable incomes, other kids, future employment).

Lintz: Why not direct contact, you're suggesting you start at the peripheral companies. Friedman: Because it doesn't appear initially that it would be successful for multinational companies. They have a limited commitment to the locality.

Gray & Lintz: I don't agree with that at all.

Friedman: Well this is...

Lintz: Results of the focus group brought this out.

Friedman: This was the sense that we got. I haven't talked to all of them. I'm speculating to a degree. The point is though, that there have been attempts made by Sue to contact all the big companies and to get them involved in the fair. Those have not been successful. They are for example, Intel is committed to the Air Show as it has been brought to my attention and that is where their contribution is. When it comes to the fair, they don't have the interest for various reasons. They are not with it.

Lintz: They don't have a parochial interest. And this would provide it?

Friedman: That's exactly it. Kids come home, and they would have a different view on it, than they do now.

Leahy: How long has this been in Marin County?

Friedman: About three years.

Leahy: What has been the growth in attendance and exhibits?

Friedman: Exhibits, limited space, not to dominate, not to take over the fair, they limit the space. Attendance - see people in high tech exhibit are upscale, other are at different economic scales. In terms of growth, I do not have exact numbers, but can tell you the numbers are growing and they are not losing.

Lintz: This started being discussed in April, do you plan, do we have the money in next year's budget for this?

Wade: We would have to advance funds to get started this year. So far as the implication of the production would come from next years budget. The \$7-10,000 would have to come from this year's budget.

Lintz: But there is nothing in this year's budget?

Wade: This wasn't event projected for this year's budget.

Thomas: Can we do it?

Gray: Questions whether the Board Members can take on part of the work so as to defray the cost.

Wade: Yes, we can do it.

Friedman: We would welcome that. We were hoping some of the high tech companies, this is a plan, like any plan subject to change this is not in written in concrete. We're not going to be billing for anything more than we do. This is not a big profit center for us in terms of our business. We would like to see this happen and we're committed to it on our side if the board is committed to it on it's side. You have to look at a plan as nothing more than that. If it doesn't need to be done, we're not going to do it.

Otten: I would think one of your main functions would be to get started in the schools. Friedman: Yes.

Otten: And that the companies would follow.

Friedman: That may well be, but they are going to have to be told about it, and they don't know about the fair, because one of the most interesting things - some of these people go to the fair who were at this focus group, but they've never looked at it from the perspective of being exhibitors there. So they don't see the numbers of people that attend, the kind of exposure that they could get from this. They don't know that they would be making a civic contribution or they probably know it subconsciously, but it has never been brought home to them. So someone needs to communicate this to them in a positive way and show them the advantages.

Thomas: What's the next step?

Friedman: I think we should have it, because... time is marching on. Did you have a question. Seems like you have more questions, and I would really welcome that. Gray: I don't have any specific questions, and I just would like to give it some more thought.

Friedman: I would hope that you would decide because time is going, and here it is almost November, coming into a holiday period; and we need to move forward with it. You're making a commitment to us and we're willing to work with you to not making a commitment to a building - anything permanent. But if this is going to happen, we have to start and work on it.

Wade: There's a real good chance, the logistics of it certainly has not been worked out. from our standpoint. But there is a real good chance that this would work out in the Armory. If not in the Armory, perhaps around the area of the Armory, by readjusting some of the area leading to the Armory. The Arts & Crafts folks would go back to the A& C building. Lot of issues here, we have to face, but it is hard to plan on it, if we don't know just where we're proceeding with it.

Gray: I think that if there is an advisory committee...

Friedman: Sure. It wouldn't be our resources. The idea would be to get industry involved in it. I'm sure the county can do it; and if you want to do it with the county then that's fine, but if we have a company that is willing to do it, then that relieves the county of the burden, which might have some benefit.

Page Six - Proposal by Bob Friedman continued Fair Board Meeting November 6, 1996

Otten: Cal has a lot of questions unanswered yet? How do you accommodate this program, Where is it going to go?

Thomas: You're thinking of the Armory, Cal?

Wade: That's what we've been tentatively thinking is using the Armory. Mainly because the A/C folks wanted to move back to the A/C's Building. If we do that, then we have to decide what to do with the Marketplace; because that has been fairly successful. I don't want to say over successful or a great big success, its been well received; so we have to deal with that issue.

Williams: What is in the Arts & Crafts?

Wade: The Marketplace, that is where we have the Washington county Marketplace. There is a possibility that that actually could fit into the Main Exhibit Building. There is room in the Main Exhibit Building in the back, by Home Economics. Personally Wade would like to stay from the mobile unit if we could. But if that doesn't work, then it might be a combination of something like the Armory. Finding a place to put it, I don't think that would be so hard, but what we have to look at closely and hard; is trying to work so it doesn't cost that much. Naturally, if we found a sponsor, that was eluded, so that it doesn't come out of the budget to keep hard costs down. The problem with the armory is getting people over to the Armory. This could be a serious problem. We have had a couple good years over there, depending on the entertainment. Something like this might grow that area, if it drew people over if it became an attraction.

Lintz: If we had something like this, like a virtual reality?

Wade: Intel, they have a virtual reality that they display at the Air Show. Maybe there is a good chance we could attract that. I don't know. Intel is very slow in responding. Gray: Asked question on how Intel was approached.

Wade: They have not been interested in fair for some reason. Because they do go into other areas. Maybe there is some back doors that need to be explored.

Williams: This is an idea that has been on the platter for five years. This is really the first innovative idea that brings a whole new group to the fair. The gentleman has a correct idea about the peripheral companies. Brings new venue that we've talked at length about, how to get new people here. Fair should make every effort to make this available and be open to a new group of kids, that may normally not come.

Lintz: One of things we need to do is review the proposal. I think we should be given the opportunity to review. We want to bring more people to the gate, and gain more interest. Gray: I want to see it happen, I just don't...

Lintz: How it happens. How we pull it off, we need to chat amongst ourselves.

Friedman: Okay. Why don't you do that. Cal has my phone number.

Lintz: You are able and willing to move forward.

Friedman: Yes. We would like a decision within the next week or two. Frankly due to the time involved with this project.

Lintz: I bet you'd be willing to move whenever we gave a call.

Page Seven - Proposal by Bob Friedman continued Fair Board Meeting November 6, 1996

Friedman: Actually, if you make it too late, we won't because there won't be enough time to get there by the time the Fair starts. So we'd have to say '98 and that's another year. That's up to the Board. We'll go with whatever you like.

Lintz: So what do you think the critical path is for this? What is the latest start?

Friedman: Well how long do you need to discuss it?

Lintz: I asked you the question first.

Friedman: I think November 15 we should know what is happening. Give you a couple of weeks to know. Gives us time this year to work on it.

Lintz: So you're saying two weeks are critical for this?

Friedman: Hard for me to say. All I'm trying to say is give us as much times as possible. Lintz: Right.

Thomas: We might not meet again until January. Most of the time we don't meet in December.

Friedman: Mr. Chairman, what did you decide? You will notify us when? What are we saying?

Thomas: What is the wish of the Board. To discuss later on in the meeting? During our second session.

Wade: Cannot during the second session. We can discuss later on in the meeting.

Lintz: We'll continue the discussion and let you know.

Marketing Research folks are thanked for their presentation and exit the meeting.

Lintz: Were you ready to give an order? Were you ready to say yes, go.

Gray: Were you?

Thomas: Yes Gray: Really

Thomas: I think its something we've wanted to do. Ken? Right? This is not my ball game. But it is something new, something different, something we've talked about. Lintz: The idea is not the issue. The issue is that we walk in here, feel uncomfortable making a decision without discussion is not right.

Gray: Agrees with Lintz.

Wade. I think this is a good point for every single issue that comes up. We should between ourselves. A decision shouldn't be made when we're right here, but that set aside.

Thomas: Is there another company that could do a better job?

Wade: I'm not concerned about the company. The concern here is logistics, I think.

Lintz: It's not just one thing. We have a tight budget. We have all these other issues that are hounding us. We need \$10,000 for this. Is there another way we can accomplish it. And if there isn't, I have to ask some questions.

Otten: Do we need to have someone call, or follow this up?

Page 8 - Proposal by Bob Friedman continued Fair Board Meeting . November 6, 1996

Lintz: Yes. My first thought is we could make a decision to say lets do this, lets go to the armory, lets test the waters for a couple, lets see how many people go over there, before we go and say here to a consultant and pay \$10,000.

Gray: I cannot do that.

Lintz: We have a focus group. I am wholeheartedly in favor of this idea, but I think procedure needs to be reviewed.

Wade: The idea came from us. Friedman knew of a similar situation in Marin County and followed through. To do something like this we have to go beyond current staff to do this and it is going to take some strong help to do.

Lintz: Could we hire a temporary?

Wade: Yes we could. I'd be real cautious about that from the standpoint that are we going to hire someone who has the ability to do this.

Gray: There are lots of places where we could reach out. We could get a report from the focus group.

Wade: Yes. Here's a report and here's another one.

Gray: Oh.

Wade: Here are the reports that have been passed out.

Gray: The only thing is the focus group, that's it.

Wade: Yes.

Gray: No, we don't have the focus group report.

Wade: That's what his says, right here, Washington County Fair Focus Group.

Gray. But you didn't give us that. You gave us this.

Wade: That was today, but before we did in September.

Gray: No, I got this in September, that's it.

Wade: Maybe I didn't, I thought we did.

Gray: No. See there's the whole missing piece. That's part of what made me feel so uncomfortable. Did we pay them for this focus group?

Wade: Yes, you bet.

Gray: Oh, we did.

Leahy: What did that run?

Wade: About \$2,000.

Gray: Holy..... I want to see the focus group before we....

Leahy: Individual school reaction?

Wade: I ran off copies of this, I'm shocked you haven't seen it.

Thomas: Do you have time to do some investigating?

Gray: I don't know.

Thomas: Sounds like the group wants to wait until January to make a decision. Right or

wrong?

Lintz: Not necessarily, but if that's our next meeting.

Page Nine - Proposal by Bob Friedman continued Fair Board Meeting November 6, 1996

Thomas: Or do we want to ask Linda to do some research and see what see what she can find out and report to us.

Wade: Gave input on the reports. Also reiterated the background of the company that performed the work. Question is does the fair board want to save some money and have the fair board do this work.

Gray: Juggling of \$7,000.

)

Wade: We can afford to make this kind of investments, we cannot afford the expense. In short, Gray to review the reports and do whatever research she feels appropriate to render decision and discuss her findings with the board and take from there. She is to call Cal with the results within one week. No motion required.

CONSENT AGENDA

In review of the financials, Wade indicated things are pretty much on target and the same as before. Wade commented on the following points: (1) Income: coming in as expected; (2) Personnel Costs: Wade indicated he is somewhat concerned about this line item. Wade indicated he is watching this closely. Costs are running at about \$15,000 per pay period. Lintz asked if the financial could reflect previous years month figures for comparison purposes. Wade indicated reports would be modified to show this request. (3)Legal fees, Wade indicated were more than what we budgeted, over by 1800-1900 in that area. (4) Under fair obligations we are over by \$770. The reason for this is the milk checks. Wade indicated it is hard to project this figure. Indicated to board we had received more income to pay for this item. Refer to item no. 182, page 14. (5) Wade also indicated total premiums were over by \$2600. Lintz commented on financials for 1995. Lintz also questioned Wade if he felt there were any abnormal situations in the budget.

Gray commented that a correction needed to be made to the minutes, page 18 middle of the page, wording should read: "Surface". Correction to be made.

Wade gave stall explanation regarding the +/- \$2,000 in the Expo Account.

Gray made motion to move the \$2000 to stall expenses. Lintz seconded the motion. Motion carried with all in favor.

Gray made motion to approve the Consent Agenda with one amendment. Lintz seconded the motion. Motion carried with all in favor.

Page Ten - Rodeo Board Fair Board Meeting November 6, 1996

RODEO BOARD

Fred Boyles gave the Board the PRCA listing of the rodeos for 1997. Boyles indicated there are a total of 401 rodeos. This data should help the Fair Board decide if a new date can be selected to accommodate some of the needs of the Rodeo. Discussion was held with Board Members about the weeks in mind. No decision was reached. Boyles also reported that at their last board meeting they had 42 people. They held meeting in the Floral Building. They were happy with this facility for their board meetings. They plan to continue using the floral or the like for their meetings. Boyles also commented that something should be mentioned to Kiewit about the maintenance of 34th street. Kiewit needs to maintain the road. Boyles felt the road is in poor condition for access. Wade made comment that original road was to be paved at the end of the project, but now it appears this should be next month. Wade indicates 34th Street should be completed within 30 days.

Lintz inquired about moving the fair dates; and how does this conflict with the dates of state fair and the eligibility of our entrants.

Wade explained and reviewed eligibility for entrants at state fair. Also clarified that state fair is the third week of August and ends on Labor Day. State fair is 10 days long. Also mentioned was the fact that we probably do not want to go into September due to the conflict with school. Wade also checked with Carnival people, they are willing to go a week after our original fair dates. They can fit us in. Wade also commented in reference to Multnomah county Fair, that this will probably be their last year.

Thomas asked question about lottery funds. Wade explained that all fairs get lottery dollars, this is in lieu of the dog racing funds.

Lintz inquired about fair dates for 1997. Wade indicated July 29 - August 3, 1997. Wade further made mention of Clark County fair dates of August 1 - August 10, 1997. Dates have been set for 1997. Wade made further comment that if we chose to move our fair closer to Clark County we may have some advertising confusion, as has been felt in the past.

Boyles to get dates and input from Jefferson County and Omak before we are to reach a decision. He will meet with them sometime soon. Board thanked Boyles for his gathering of the Rodeo detail and thanked Wade for the input on fair.

Discussion was held regarding the ticket policy held by Funtastic. Wade commented they do not take yesterdays tickets. Funtastic personnel should have instructed you to the office. Burback indicates today's tickets need to be redeemed in the office for the right color. Wade indicated Funtastic's willingness to work with the Board.

Lintz would like profile of the carnival companies for the next meeting. Wade responded by giving the strengths and weakness of Davis, Butler and Fantastic. Wade also commented on the types of rides that are brought to fair, they are part of the contract. Wade is to invite Ron Burback of Funtastic to make a presentation at the next board meeting.

Page Eleven - Boosters Fair Board Meeting November 6, 1996

BOOSTERS

There was no report from the Boosters, nor any report given for the meeting.

4-H HORSE FAIR

There was no report from this organization, nor any report given for the meeting.

MARKETING

Marketing Representative report was very brief, due to the request of the Board. Garza referred everyone to review the calendar for upcoming events in the Packet. Garza further stated that November and October have been relatively busy. Garza also stated that in the last couple of weeks she has issued over 15 contracts, worth \$10,000 in revenue to the Fair Complex. New contracts went to Girls Scouts and Video Liquidators.

MAINTENANCE

Jim Jordan reported the following:

- Mike Wold has been working on the boat storage and the Barns. Mike has also been helping Jim with the electrical project near the Floral and Cloverleaf.
- Jim indicated he had been working on the electrical upgrades by the Floral and the Cloverleaf. Also mentioned to Board he has upgraded the phone system in both those buildings. We now have 5 lines into those buildings.
- Earl Bemis has been working on the Meeting Room, making it more presentable. Also working on: Rabbit/Poultry to clean the building; Cloverleaf in painting and minor repairs; Floral in repairing the structural and water damage to the ceiling which is sagging.
- Albert Flanagan continues to work with events. He is very busy. Also is working with the restitution center workers to rake up the leaves.

One additional comment Jim made to the Board. The Haunted Cave people were just here and they left the Fair Complex with some benefits. We now have a full fire alarm system in the Main Exhibit Building. Smoke detector hooked into the alarm and sprinkler system. Not presently monitored. This was a requirement of the Fire Marshall for this event.

In summary, every one in Maintenance has been very busy.

Page Twelve - Old Business Fair Board Meeting November 6, 1996

OLD BUSINESS

A. DOG LEG

Lintz reported the Subcommittee (Wade, Leahy, Lintz) had met with Tri-Met. Lintz discussed the chronology of the dirt removal. Lintz suggested to the Board that a letter be written to Kiewit allowing them a tax credit for the fair value of the dirt and a letter that met the tax laws for credits by IRS. Wade is to write the letter to this effect. Discussion was also held by Leahy regarding the dirt removal. Leahy is to do some checking and research in the dirt removal for this project and related construction projects in the area. Leahy will contact Wade and the Board upon any discovery.

Also Lintz brought to the Boards attention the need for an appraisal on the property in order to better determine the fair price of the property. The appraisal to date has been a very difficult piece of information to obtain from Tri-Met and related parties.

Motion was made by Lintz to have Dan Olsen, County Legal Counsel, request an appraisal of the Dog Leg Property. Motion was seconded by Leahy. Motion carried with all in favor.

B. FAIR RECOGNITION NIGHT

Wade reminded Board that November 21, 1996 is the day for the Fair Recognition night. Gray gave overview of agenda for that night. She also reminded Board members of their duties and assignments for that night. Board members to make presentation to award winners and be present for this event.

C. CELL PHONE RELAY TOWER

Wade reported that the deal with cell phone relay tower had been lost. We offered them \$1000. Wade made several telephone calls to the Cell Phone Relay Tower with no avail. They suggested to Wade that they would get back to him. To this date, Wade has not heard from the Tower folks.

On a separate occasion, Wade has an opportunity to meet with John Newall of the Port and Newall indicated, the Cell Phone Relay Tower is putting the tower over on the Airport premises.

No further action on this item at this time.

Page 13 - Old Business continued Fair Board Meeting November 6, 1996

D. DRAFT HORSE SHOW

Wade indicated that there was really nothing new to report other than they had had a meeting. The results of the meeting were favorable for fair. Wade referenced to the contents of the minutes, pages 28-29 for further information regarding this item. Boyles made a comment about a correction to Page 28, 5th paragraph should read "....Dodge City...".

NEW BUSINESS

A. 1997 FAIR THEME - " A BLAST FROM THE PAST" APPROVAL

Wade introduced the new theme for the fair in 1997 - "A Blast from the Past". Indicated the staff had come up with the theme. Wade asked the Board for their input. Board had no real input.

Motion was made by Otten to approve the 1997 fair theme. Motion was seconded by Lintz. Motion carried with all in favor.

B. ST. MARY'S OF THE VALLEY

Gray and Lintz inquired about the negotiations with St. Mary's of the Valley. Garza and Wade responded by indicating that the Sisters wanted to move their annual Valley Fest to the Fairgrounds. The Sisters were tired of their property being torn up due to the inclement weather. Garza indicated the event was to take place on May 24, and 25, 1997. Garza further indicated that the Fair Complex does have another event scheduled for those same exact dates in the Main Exhibit Hall. If the carnival grounds, and or the Parking Lot on 34th Street were used for the Valley Fest, the Fair Complex would have a problem with the parking for the event in the Main Exhibit Hall. Wade also discussed the revenue aspect of this potential event, indicating Fair Complex would want to do something like what we do with other carnivals and that is to take a per centage. Wade and Garza do not feel Valley Fest would be amenable to this. Also Wade cited that this carnival could be a problem for the Fair Complex's other carnivals (4th of July and Fair) due to the proximity in dates.


