## PUBLIC WELCOME

Addie Fisher, Fairgrounds Booster member, stated her concern about county commissioners being appointed to the Fair Board. She was advised that John Meek was serving as an appointed Fair Board member and that comments regarding his appointment should be made directly to the Board of Commissioners.

Rocky Williams, Rodeo Committee chairman, stated that his committee also had objections to county commissioners being appointed to the Fair Board, but would take their concerns to the Commissioners. John Meek suggested that their objections and supporting reasons be submitted to the Commissioners in writing.

Williams reported he was in the process of completing the Rodeo Committee budget. He stated the Rodeo Committee was negotiating with an individual regarding sponsorship of part of the rodeo. A written proposal will be submitted to the Fair Board for approval. He also discussed the possibility of an Exhibitor Cutting Class performing. An amateur High School Rodeo night has also been proposed by the committee. Hesse stated they had considered a greased pig contest for Thursday evening's grandstand entertainment. Due to the current controversy regarding this type of activity, there may be an age limit for contestants, if held.

## ELECTION OF OFFICERS

NOMINATED BY JOHN MEEK, SECONDED BY HOMER SPEER, TO ELECT MARGARET SPRECHER AS CHAIRMAN OF THE FAIR BOARD. MOTION CARRIED.

NOMINATED BY JOHN MEEK, SECONDED BY MARGARET SPRECHER TO ELECT HOMER SPEER AS VICE CHAIRMAN OF THE FAIR BOARD. MOTION CARRIED.

NOMINATED BY JOHN MEEK, SECONDED BY MARGARET SPRECHER TO ELECT LLOYD BARON TREASURER OF THE FAIR BOARD. MOTION CARRIED.

## MAIN ENTRANCE DESIGN

Architect, Stan Rickard, attended the meeting and addressed the Board concerning three proposed main entrance designs. Rickard said the main entrance had several criteria, i.e. entry statement, clean, contemporary, blends with fairgrounds building designs, low maintenance, and vandal proof. Each scheme was described by Rickard who was then open to questions or suggestions from Board members.

Homer Speer suggested contacting other fairs and obtaining comments regarding their entrances. Exiting, peak hours of ticket sales, comfort, space, and ability to accommodate for future additions were all discussed. The board agreed quality was of great importance. Hesse and Rickard reviewed 5 entrance designs from photographs Hesse took in California. No fair in the state of Oregon has a major free standing entrance.

Rickard will take suggestions and discussion into consideration in preparing a proposed entrance for Hesse's approval.

## CORNELL ROAD CONSTRUCTION

Hesse and Senator Hamby were scheduled to meet with Walt Bartell regarding construction of the fairgrounds road. However, Bartell did not attend the meeting. The fairgrounds may pay the cost to reclaim rock. Hesse will proceed with the matter.

#### FAIR BOARD APPOINTMENTS

The Board of County Commissioners appointed John Meek, who was welcomed to the Fair Board. Margaret Sprecher was reappointed for a second term.

## PERSONNEL POLICY MANUEL

A Personnel Policy and Employee Benefits Summary was drafted by the Executive Director. Homer Speer, Margaret Sprecher, and Hesse met and redrafted the same. The Board was asked to comment and revise if needed. John Meek suggested the Executive Director be provided with life insurance coverage  $1\frac{1}{2}$  times salary.

MOTION: MOVED BY JOHN MEEK, SECONDED BY HOMER SPEER TO ADD PARAGRAPH IN POLICY TO PROVIDE EXECUTIVE DIRECTOR WITH LIFE INSURANCE BENEFITS 1½ TIMES SALARY. MOTION CARRIED.

The Board approved the policy and it will be forwarded to county counsel for review.

## MISS WASHINGTON COUNTY FAIR & RODEO

The 1985 Miss Washington County Fair & Rodeo is Melissa Braun. Debbie Spencer will be chaperone. Rocky Williams reported outfits will be more feminine.

# HOME EC SUPERINTENDENT

Nancy Raber has resigned as Open Class Home Ec Superintendent. A replacement has not yet been found. Hesse suggested Jeanne Leeson be asked to prepare a news release to help locate the new superintendent. Fair Board members were also asked to locate responsible, qualified individuals.

# ALCOHOLIC BEVERAGE POLICY

The Board reviewed an alcoholic beverage policy drafted by Hesse. There was some discussion regarding policies pertaining to private parties held on the fairgrounds. Members had no objections to the proposed policy and Hesse will forward it to county counsel for review.

# COMP & ZONE CHANGE

The City of Hillsboro granted approval for zone change. Request for final approval will be sent to Washington County. Nancy Gordinier will follow through on the Fair Board's behalf.

#### HOTEL/MOTEL TAX

Hotel/Motel tax Resolution and Order was reviewed. Funds from the tax will be expended in fiscal year 1985-86. Washington County would be required to submit a supplemental budget if funds were to be disbursed prior to the next fiscal year.

#### PARKING LOT

The Fair Board compared proposals from Washington County and Peterson Land Surveying for design, construction and mangement of 6.8 acre parking lot. Hesse is working with PGE on a lighting design for the parking lot and will keep the Fair Board informed as to whether we can utilize a PGE system or will need to look at installation and design by a private firm.

MOTION: MOVED BY JOHN MEEK, SECONDED BY HOMER SPEER, TO HIRE PETERSON LAND SURVEYING TO DESIGN AND OVERSEE BUILDING OF A ROCK PARKING LOT, TO DEVELOP A MASTER DRAINAGE PLAN, AND TO SURVEY THE ENTIRE FAIRGROUNDS. MOTION CARRIED.

## COUNTY AUCTION

All items submitted by the Fair Board sold at the county auction. Net proceeds to the fairgrounds was \$149.47. A water truck was purchased from Unified Sewerage at a cost of \$1,200.

## OPERATIONS SUPERINTENDENT'S REPORT

Operations Superintendent, Ron McAuley, reported jobs accomplished in November were, formica backsplashes in the Cloverleaf Community Building, formica on existing counter tops, D.J. Smith Enterprise moved the mobile home, and R.V.'s and boats were moved in for storage.

December projects completed were remodeled Main Exhibit Building kitchen, rebuilt and painted A-Boards and built new A-Boards. January projects to be completed are painting the Main Exhibit Building restrooms, start storage building, and paint floors in the Cloverleaf Community Building restrooms and the Main Exhibit Building restrooms.

## AREA MEETING

Sprecher, alternate Area I OFA director, and Hesse, OFA Director-at-Large, attended a meeting with legislators in Pacific City. Board members were encouraged to meet with legislators and express any concerns to them.

# HOTEL/MOTEL TAX POLITICAL ACTION COMMITTEE

John Meek reported on the December 14, 1984 PAC meeting. The temporary name of the committee is "People for Progress". The committee hired Betty Atteberry to coordinate the campaign and write the brochure. Margaret Sprecher is chairman of the fund raising committee. Sprecher invited the Fair Board members to help or offer suggestions.

## 1985 FAIR ENTERTAINMENT FORMAT

The Board reviewed a draft of the 1985 Fair entertainment format. Tuesday, August 6 will be Family Day, Wednesday, August 7, Senior Day, Thursday, Washington Federal and Western Hat Day, Friday, August 9, Youth Appreciation Day, and Saturday, August 10, Chamber Day.
