CARETAKER INTERVIEWS

GROUNDS REPORT

Mr. Ball stated work on the fence has commenced. Mr. Adams asked Mr. Ball to hire help to get the grounds greened up for the fair. Eight floodlights will be installed for the new arena. Mr. Jossy will check on progress of sewer. Mr. VanDyke mentioned getting the P.A. system in good working order for the horse barns.

DRESSING ROOM FOR HORSE EXHIBITORS

Mr. Springer said he has been approached by several people to take action on getting dressing facilities out at the horse barns. It is late for the 1973 Fair but Mr. Jossy will try to work something out if possible.

1973 HILLSBORO HAPPY DAYS -- JAYCEES

Mr. Jossy gave a brief report on some of the observations he made during the Happy Days Celebration. The County Fire Marshall has prohibited sale of fireworks on the grounds which previously was a heavy source of revenue for the Jaycees. Jossy noted damage had been done to the restrooms and a water shut off valve was broken off. Mr. Springer suggested the Happy Days (Jaycees) be billed for the damage.

GROUNDS RENTAL FROM BLAKE CARNIVAL

Jossy negotiated with Mr. Blake on the use of the barns during the period of October, 1972 to March, 1973. Blake has paid the Fair \$900.00. Also, Mr. Blake gave the Board an old GMC truck.

FLOAT IN THE 4TH OF JULY PARADE

The Board discussed entering a float in the 1974 4th of July Parade in Hillsboro. Mr. VanDyke will take charge.

ROBERT E. MEYER ENGINEERS, INC. LONG-RANGE PLANNING

Mr. Robert Meyer, Engineer, and Mr. Jerry Draggoo, Planner, made a presentation to the Fair Board in regard to long range planning for the fairgrounds. In the presentation, Mr. Graggoo discussed the role of the planner and the input of the Fair Board. Three phases were recommended: Phase One

1. Inventory of the present site 2. Evaluation of space needs 3. Forecast demand Phase Two

4. Preparation of site development plan Phase Three

5. Development of a Capital Improvement Program. Hr. Meyers will send a representative to the 1973

Fair for abservation purposes and then supply a dollar figure for a long range plan. Mr. Adams mentioned going to the County but said we need to keep an open mind to a private consulting firm.

VETERINARIAN HIRED

Dr. R. Younce has been hired to enforce the General Livestock Health Requirements listed in the premium book. Inspection will take place from 5:00 p.m. Monday, July 30 to Tuesday, July 31 until he has finished. He will also return on Friday, August 3 to inspect incoming beef.

DAIRY WASHING FACILITIES

Joe Evers asked about some improvement for washing milking equipment during the fair, namely requesting a hot water tank. Evers offered donating milk to purchase the desired supplies. It was suggested that in the future such facilities could be installed with the Dairymen making donations to the Board, rather than actually donation of the milk from the Fair.
