## HORSE MANURE

The Fair Board was advised of a problem with horse manure on 25th Avenue which was handled well by Lyle Spiesschaert, 4-H extension agent.

## READER BOARD

The Board discussed a letter received from Don McCoun, KUIK radio station owner, questioning use of only one side of the reader board by a paying function. The board reviewed their policy and the policy stood per board consensus.

## ANIMAL INSURANCE

Hesse reported that the Leonard Adams Company has been unable to secure the total liability exposure limits for housing of livestock on the fairgrounds. They secured three quotations, none of which were acceptable. Hesse will pursue the matter further until a coverage meets the fairgrounds' needs.

#### DERBY FINANCIAL

Hesse reviewed the July 4 Destruction Derby financial recap. Admission was down 553, expenses increased (i.e. Hillsboro Towing \$200, insurance doubled). Overall, profits were down by approximately \$4,000.00.

## TASK FORCE

The task force met July 11, 1984. Hesse and J. Leeson attended. David Leland of Leland & Hobson has become a member of the task force. Hesse and Leeson both reported the task force appeared to be dividing. One group felt the value of the property was overrated, the timing was wrong, and after submitting their report, their job was finished. The other portion appeared to be ready to advise the Fair Board further. The Board wishes furthur financial advise from the task force after submitting their report. It was suggested that some of the members of the task force continue on a on-call basis.

Hesse and Sprecher attended the City of Hillsboro Zoning and Hearing Board meeting June 20, 1984, regarding the fairgrounds comp plan and zone change. The hearings board chairman ruled that a zone change cannot be granted until the comprehensive plan amendment has been granted in October, 1984. City Staff, with urging from the task force and fair board, has written a statment which will allow for an additional access, egress to the fairgrounds commercial property.

## FAIRGROUNDS BOOSTERS

The Boosters met June 6, 1984 and discussed the information booth at the fair. They would provide information on the hotel/motel tax, membership and other activities.

## BOARD MEETINGS

The Board decided to meet twice during fair week. Meeting dates will be Wednesday, August 8 at 1:00 p.m. and Friday, August 10 at 1:00 p.m. Financial reports will be available for review. Bert Allenby is the merit rater and will be on the grounds August 9 and 10.

## SOROPTIMIST

The Hillsboro Soroptimist presented the Fair Board with a trophy for 1st Place in the Hillsboro Happy Days Parade and also a trophy for the Sweepstakes Award.

#### BUDGET

Hesse was originally advised the county budget was approved, but it's possible it may be out. The problem appears to be the cash carry over. The Board discussed future expenditures, i.e. road improvements, that will take a substantial amount of the carry over. Hesse will obtain information from other fair boards on incorporation. Lloyd Baron suggested the idea of establishing a taxing district.

#### CHUTE SIGNS

Rodeo chute and arena information was reviewed. Rocky Williams, Rodeo Chairman is distributing the sales packets. The signs are being sold by personal contacts only.

#### **ADVERTISING**

The 1984 Advertising Schedule was reviewed. Bus cards, fair programs, newspaper ads and coupons will have the same graphics.

#### **NEW EXTENSION AGENT**

Nancy Kershaw is the new 4-H extension agent and will be at work by August 1.

#### CORNELL ROAD

Baker Rock Crushing was awarded the bid on Cornell Road. They will begin work any day. They have a fenced compound at the east end of the fairgrounds. They have provided the fairgrounds with a million dollar umbrella.

## OPERATION SUPERINTENDENT'S REPORT

The Cloverleaf Community Building kitchen is close to completion. Plumbing, cabinets, and electrical work is finished. A few minor details remain unfinished.

Electrical problems are being resolved and should be completed by Monday, July 16.

Happy Days damage is being repaired. They left a lot of garbage. Hesse suggested a \$500 clean-up fee next year.

#### FAIR PROGRAM

Jeanne Leeson updated everyone on fair program articles. She submitted 22 pages of copy for the program.

#### RODEO

No report on the Rodeo Board meeting as John Love was not present. Hesse advised the Rodeo Court appeared at the Forest Grove Chamber of Commerce, promoting the fair by passing out information on Chamber Day and the Reno drawing contest.
