ADDITION TO PREMIUM BOOK ARTS & CRAFTS Hesse reported error in premium book regarding Arts & Crafts department. The creative stitchery was not included in the book.

MOTION. MOVED BY RALPH HOLLAND, SECONDED BY JERRY BOYER TO INCLUDE CREATIVE STITCHERY IN THE 1976 PREMIUM BOOK IN AN ADDITION SHEET WITH PREMIUMS TO BE ALLOWED. MOTION CARRIED.

RODEO PROGRAM

Jossy read a report to the Board concerning activities on selling of ads in the proposed rodeo program. Stipulation was made that no advertisers from the County Fair Premium Book were to be contacted. The agreement was made in April of 1976.

July 14 Jerry Boyer was called via telephone by Sports Action Service, Tulsa, Oklahoma to purchase a 1/16 page ad in the rodeo program for \$28.00. It has become apparent that the County Fair Premium Book is being used as the nucleus to sell ads in support of the rodeo and fair for the rodeo program. Jossy was also called at his Willamette Production Credit Assn. Bank to purchase an ad.

The Fair Board does not do business in this manner and therefore instructed an immediate stop to selling ads (from premium book).

Resulting from the wildcat activity were the following concerns and results noted by the Manager and Board:

- 1. The Rodeo Board and Sports Action have gone ahead with the program against the explicit reasonable request of Jim Springer, Dick Jossy and Ken Lewis.
- 2. The result is all of our ad buyers in the premium book are being contacted by Sports Action by telephone and hit up for more support.
- 3. The premium book is being maligned before our present advertisers.
- 4. I expect to have serious problems getting the support of the community buying ads next year also possibly problems getting anyone to sell them.

MOTION. MOVED BY RALPH HOLLAND, SECONDED BY JERRY BOYER THAT THE MANAGER BE INSTRUCTED TO SEND A LETTER TO ALL RODEO BOARD MEMBERS DETAILING THE PROBLEM AND TELLING THEM TO CEASE THE PROGRAM IMMEDIATELY. ENCLOSURE IN EACH LETTER WILL INCLUDE THE MANAGER PREPARED REPORT AND MINUTES OF THE JULY 14, 1976, MEETING. MOTION CARRIED UNANIMOUSLY.

HILLSBORO HAPPY DAYS DAMAGE

The following damage occurred during the Hillsboro Happy Days:

- 1. Leg broken off the main sign board.
- 2. Power line from floral bldg. to main exhibit bldg. torn down.
- 3. Office steps hit and torn off.
- 4. 16 wire communication cables torn down.
  Holland suggested when negotiations take place for the 1977
  Happy Days contract the above items will be considered.
  Jaycees have paid for use of the fairgrounds for the '76 event.

RENTAL OF ARMORY 4-H

Major Leland Anderson called and reported overtime wages only will be charged the Fair for use of Hillsboro Armory. Armory is being rented to house 4-H exhibits during the county fair.

PASTURE RENT

MOTION. MOVED BY RALPH HOLLAND, SECONDED BY JOE VANDYKE TO CHARGE \$6 PER HEAD PER MONTH FOR PASTURE LESS FERTILIZER AND APPLICATION (\$405.). MOTION CARRIED.

BUILDING SHOW RINGS

Forest Grove FFA chapter is building new show rings.

SHERIFFS RESERVE BLDG. TO BE PAINTED Management will call sheriffs reserve and ask them to paint their building before the fair. Fair Board will supply paint

CONDITION OF ARENA

Paul Knapp, 4-H leader asked permission to move in local arena refuse to loosen up the arena ground. Fair Board will work with the 4-Hers and will work the refuse in the arena ground.
