At this point the county representatives left the meeting.

Mr. Holt asked the Board if they would be willing to purchase the plaque for the base of the totem pole. He was advised to check on prices, etc. first.

Holt had received a request from Ron Furby to do remote broadcasting from the fairgrounds under the call letters of KYDS. The board OK'd this.

Holt asked if portable toilets could be installed for the 4-H horse show this weekend. The Board ok'd this.

As there wasno further business, the meeting was adjourned at 1:45 p.m.

Washington County Fair Board - Special Meeting - Merrill's Cafe.

Members present: Dick Jossy, Al Lindow, Lyell Gardner, Earl C. Adams and Glenn Holt.
Absent: Ken McGough, Betty Shearer and Ed Ball.
Visitors: Dick Walsh and Mel Jasmin and assistant?

Dick Walsh explained his version of the show and said there were no real problems at Bull Frog Lake. He plans carnival, art show, balloon, show for kids and County Western stars. Admission \$6.00 in advance and \$7.00 at gate.

He stated he would furnish adequate security guards 24 hours per day and enough portable restrooms to cope with the crowd. 20,000 people planned. Dates Aug. 22 and 23. He will furnish clean up crew ~~xxxx~~ and fair will supervise ticket sales.

Chairman Dick indicated to them that it is the duty of the Board to see that the Fairgrounds are used to the best advantage for the people in the county.

The Board indicated adequate insurance had to be provided. A verbal poll of the Board indicated their approval of the promotion. These three men left at this point.

After discussion, Al Lindow moved we have the county do our paving, seconded by Earl Adams and passed ~~by~~ by Board members

Lyell Gardner suggested that Ed purchase necessary equipment to work arena and that said purchase be made from Scott's Machinery or Oliver Sales and Service.

Earl Adams asked that arena be in good condition for Horse Show.
