Mrs. Hesse reported on her meeting with Ken Johnson, Port of Portland, Jerry Draggoo, Robert E. Meyer, Eng. Inc., and Brent Lambert, Washington County Interim Park Director. The County Commissioners have approved the Fair Board application for an Economic Impact Study. Johnson reported that the Port of Portland does not have the necessary expertise to produce a commercial economic study. Johnson will take the application back for a management decision. Mrs. Hesse will meet with Lewis Myatt Monday, July 11, to set up the agenda for the Citizen Steering Committee meeting. It was decided the Committee meeting will be held Tuesday, July 12 at 7:30 p.m. at the Fair Office.

DESTRUCTION DERBY

The revised Destruction Derby contract has been okayed by County Counsel after a meeting with Mrs. Hesse and Mr. Colegrove.

RODEO BOARD MINUTES An error regarding groups picking up debris after the destruction derby was noted in the rodeo minutes. Debris pickup contests will be held for 4-H and FFA youth group teams of 5, not Boy Scouts. It was also; noted in the Rodeo minutes that the Evers cattle had damaged fences in the rodeo area. Fair Board will have maintenance person make the necessary repairs. Rodeo Board will whitewash the shutes. Discussion was also held on the advertising fee that was to be paid by the Fair by July 15 and the following motion resulted.

MOTION: MOVED BY RALPH HOLLAND, SECONDED BY CHARLES COLE-GROVE TO DELAY REQUESTED PAYMENT FOR RODEO ADVERTISING FEE OF \$1520.85 UNTIL PROOF OF PERFORMANCE. MOTION CARRIED.

Al Young reported the Jaycees replaced the compressor on the 4-H cooler in the chuckwagon. A settlement of the cost of the compressor will be handled through the Fair Office.

4-H WORKDAY

A 4-H work day will be Saturday, July 9. Seventy-five 4-H youth have signed up. The day will be coordinated by Charles Colegrove and Al Mohr.

HAY

The hay raked and piled on the fairgrounds will be disposed of to eliminate a possible fire hazard. Jim Springer has sold hay to the Fair for rodeo stock. Springer offered a donation of hay for the Touch 'n See animal farm.

WATER PUMP

B&H Electric repaired the switch on the water irrigation pump. irrigation is commencing to green up the fairgrounds.

MEDECA

Mrs. Hesse asked for Board imput regarding offer of MEDECA to dance during the Fair. Cost to the Fair is \$20.00. Fair Board approved the invitation and small fee.

OPTIMIST CLUB

Jim Springer and Ralph Holland will attend a meeting of the Beaverton Optimist Club July 14 to disperse information about the upcoming Fair.

YEAR END FINANCIAL STATEMENT After Fair Board review of the year end financial statement it was noted by Board and Manager that certain catagories of the 1976-77 operating (expense) budget were exdeeded. The unexpected operating expenses were primarily inflationary or a balance item that produced revenue such as ad sales and reflected in professional services and gate change.

MOTION: MOVED BY RALPH HOLLAND, SECONDED BY CHARLES COLEGROVE TO TRANSFER MONIES FROM UNDERSPENT CAPITAL OUTLAY CATAGORY TO COVER THE EXCEEDED ITEMS OF EXHIBITS AND COMPETITION. MOTION CARRIED.

MOTION: MOVED BY HOLLAND, SECONDED BY COLEGROVE TO TRANSFER MONIES FROM THE CONTINGENCY FUND TO COVER EXCEEDED ITEMS IN THE MATERIALS AND SERVICES CATAGORY. MOTION CARRIED.

A signature is needed on the license for the wine tasting booth booked for the 1977 Fair by The Grapery. Mrs. Hesse will sign the license.

TOUCH & SEE ANIMAL SHOW

Someone will be hired to supervise this event. The Board will submit suggestions at the next Board meeting. Jim Springer will donate hay for the animals.
